We will travel just a hop, skip, and a jump up the road to recognize Past PCEA National Presidents in attendance and celebrate the accomplishments of the current administration.


"The Club" at Bennie's Red Barn is a rustic, indoor /outdoor venue located just next door to the restaurant portion of the Red Barn. Our group will have the club and famous "TREEBAR" to ourselves until the band starts and opens up to the general public. Grab a cocktail , watch the game on either of the 2 big screens, step away from the action to enjoy the two outdoor fireplaces, or dust off those dancing shoes and hit the dance floor!

Bennie's Red Barn is the oldest, privately owned restaurant on St. Simons Island. Bennie & Louise Gentile built the barn to be a restaurant. When Bennie was in the war in Germany, he took cover in an old barn. It is said the interior of that barn, was his inspiration for building this restaurant. The wood in the main structure was cut & milled on St. Simons Island. The large driveway posts were recovered from the original wooden causeways over to the island. Many of the bricks were repurposed from old warehouses in middle Georgia. You may even find yourself sitting in a chair from the grand dining room of the historical Oglethorpe Hotel.

This is a "must visit" on your trip to the Golden Isles!

The course at Sea Palms resort was designed by George Cobb and Tom Jackson in 1967. The course has established itself as one of the Golden Isles' most rewarding courses, offering challenging play for golfers of all skill levels.

In his prime, George Cobb created more than 100 original golf course designs, along with dozens of redesigns. His most promi-



nent design is his shortest course – the Par 3 Course at Augusta National Golf Club, completed in 1959. He was also the original designer of Quail Hollow Golf Club in Charlotte NC.

Golf Tournament

Recent renovations to the course have many raving. Bunkers have been rebuilt, reshaped and replaced with brilliant white G-angle sand. Native ornamental grasses were also planted in strategic areas which have raised the aesthetic appeal. The course plays to a par of 71. At just under 6,500 yards from the tips, the course is not long by today's standards. The pines, palms and palmetto trees that line the fairways along with some overhanging moss place a premium on driving accuracy. The water-lined 18th is a terrific finishing hole. **Cost: \$100 Per Player**

Integrated Project Delivery

Presented by Ford Hazelip, Hoar Construction

IPD (integrated project delivery), a type of contractual agreement, has helped to foster a greater level of collaboration on some projects.

IPD combines ideas from integrated practice and lean construction to solve several problems in contemporary construction such as low productivity and waste, time overruns, quality issues, and conflicts during construction among the key stakeholders of owner, architect and contractor. The growing use of building information modeling in the construction industry is allowing far greater information collaboration between project participants using IPD and considered an important tool to increasing productivity throughout the construction process.

Unlike the design-build project delivery method which places the contractor in the leading role on a building project, IPD represents a return to the true team concept where the entire building team including the owner, architect, general contractor, building engineers, fabricators, and subcontractors work collaboratively throughout the construction process.

Ford is pre-construction manager at Hoar Construction in Orlando, FL and is currently leading the preconstruction and pricing efforts on an IPD project with a large owner In Central Florida.



The Impacts of the Clean Water Act on Construction in 2015

What to plan for, options to consider, and what to expect next. Presented by John Moll, Crystal Stream Technologies

John will explain the meaning of water quality treatment specifications for compliance with the Clean Water Act and how to comply with a numerical specification. In addition, he will cover how to respond to a specific product or structure based specification and how to assess an "or equal" product. Possible cost savings that are associated with the use of manufactured products in lieu of public domain structures will be covered along with potential approval issues. A discussion of the current rules and regulations and the likely changes coming from the EPA over the next few years will also be included. Questions and open discussion will be encouraged.

John Moll is the CEO and Research Chief for Crystal Stream Technologies, where he directs all research, engineering work and executive duties. His training at Florida State University as a geologist led him to today's work of separating particles from moving water. He holds eight patents for water quality technology, and it actively working to better understand the chemistry and physics of pollution wash-off, transportation and capture. John was the founder and first President of SWEMA (Storm Water Equipment Manufacturer's Association
