#### **ELIGIBILITY:**

Prospective reseller must be in the professional business of selling auxiliary lights. In addition to completing the Baja Designs business application, prospective RESELLER will provide copies of a business license, resale number/sellers permit California only), and website address. Pricing will be determined by opening purchase and annual purchasing. See attached reseller levels.

#### M.A.P. POLICY:

In an effort to maintain the premier high quality reputation of Baja Designs, Inc. and the proper market positioning of its Lighting Products, a Minimum Advertised Price Policy (M.A.P.) has been established. RESELLER agrees to abide by said policy and will not advertise, promote, or market via television, print, and/or internet media below the specified M.A.P. Pricing prescribed on the RESELLER price sheet. Failure to abide by the agreement will terminate and forfeit said RESELLER status.

#### **PAYMENT TERMS:**

All new RESELLERS must pay by Credit Card until the business application has been completed in full and approved for terms. CREDIT CARD - We accept VISA, MasterCard, American Express, and Discover. Net 30 - Payment terms of Net 30 Days from date of invoice are available on approved credit. Interest will be charged at 1.5% per month for any past due invoices. Invoices 90 days past due will be assigned to a collection agency or referred for legal action.

#### N.S.F. CHECKS:

Any checks returned to Baja Designs are subject to a \$25.00 fee. Any other fees associated with the collection of funds will be the responsibility of the RESELLER.

All returns are subject to a 15% restocking fee.
