**Directions** to Black Dog Farm: From the 15 Freeway (north or south) take the Clinton Keith off ramp. Travel west 6.9 miles to stop sign, Tenaja Rd, turn Right. Go 1.7 miles to Harkey Circle, turn Left. You have arrived. Trailer parking is in the field on the right in approximately 1/8 mile—at the end of the pasture fence line.

**Did you know** that a horse may be shown by two riders? The horse must be ridden in the same level or the next consecutive level –maximum of 3 tests (4 tests permitted, if 2 are USDF Intro tests) – Equitation not counted as a test. Each horse/rider combination must complete a *separate entry* form. Drug fee and grounds fee per horse (2 riders 1 horse = 1 drug/grounds fee)
