Don serves as the Immediate Past President of NAADAC, and is a Senior Fulbright Scholar with the NAADAC Trainers Academy. Don's PhD is Counselor Education and Supervision at Indiana State University, and member of the Association of Counselor Educators and Supervisors (ACES).

The afternoon session will focus on issues of due process, informed consent, liability, and malpractice. The ACES ethics code will be examined for duties, standards and expectations of clinical supervision.

Don will present findings from his doctoral research related to clinical supervision and addictions.
