JCI should lobby to be recognized as an educational institution with the power to award a certificate or diploma to those who successfully complete its objectives.

In my experience, the best attribute of Jaycees is the development of the individual. This is achieved through giving the individual the skills necessary to succeed and the self-esteem to try.

I have often related the story of Gus (name changed to protect his identity) who joined my unit in the 70's. Gus was a diminutive man with a limited education who worked for menial wages in a dead end job for a small family owned electronics business.

How he heard about Jaycees or who brought him out I do not know. In any event, he was made to feel welcome and became hooked on Jaycees. He participated in courses. He volunteered for committees. In his second year, he became secretary of the unit and successively moved up in the executive in following years. In the unit, it was usual to move up in the executive to eventually become president. It became Gus' turn to become president, but he lost an election to a less than two year member who had brought a number of his employees into the unit and had bucks to throw around. That was the catalyst that Gus with his new-found self-esteem needed to quit not only Jaycees, but also, his job. He started up his own business in a related product. That business thrived and exists to this day.

But that is not the end of the story. Gus really believed in the Jaycee Creed. He joined the Salvation Army and over the years has held, and still holds, senior responsible positions in that organization. He has helped hundreds, if not thousands of those less fortunate over the decades. Although the circumstances of his departure from Jaycees were not pleasant, he credits Jaycees for his success in business and the Salvation Army.

Jaycees not only benefits the individual, it benefits the communities in which we live, locally, provincially, federally and internationally. I cannot count the vast number of stories I have read in this Newsletter and elsewhere about Jaycees who have gone on to provide exemplary service at various levels to the community through involvement in all levels of government, school boards, service clubs, religious institutions, and volunteer service to any number of charitable organizations.

I have often thought we should establish a junior affiliate of Jaycees in our high schools. If self-esteem can be engendered in students lacking it, a higher percentage would strive to become achievers in life. My unit did go into the local high schools but were not afforded the opportunity to teach and, of course, with the age restriction could not enroll under 18 year-olds as members. I was delighted to learn that my fellow Senator "Awesome" Astrid Wadnipar-Machon 68004, JCI Canada Whitby by 2011 President" has used high school students looking for community service credits as volunteers for Jaycee projects such as the annual Santa Claus parade. I am certain that that contact will lead to a number of those students joining the unit when they attain the age and have the opportunity.

By giving the individual the opportunity, Jaycees enable the individual to succeed and a successful Jaycee inevitably betters the community in every way. This is the objective of educational institutions everywhere, so why not Jaycee College or University?

1) Registrations now total 72. This includes Senators from Australia, Germany and England as well as several Americans. The cost is now up to a still - affordable \$155.00 per person for a full registration.

2) London, Ontario is officially the home of the "Best Ball Park" in Canada. Labatt Park is Canada's oldest ball park and has been voted most Favourite Park in a cross - Canada survey. It happens to be just 15 minutes from the Hilton London and some of you may be able to see it from your hotel room if you do not want to venture out.

3) The Friday Night at the Top of the Fair is filling up fast. This is the same night as one of the richest purses up for grabs at the race track for the whole season. You need to register **A.S.A.P.** in order to take advantage of this deal. I will have more info next month on this event. Be assured that there will be plenty of other restaurants within walking distance of the Hotel as well.

4) The Double-Decker Tour Bus is limited to 60 passengers. This is a two hour ride and is very popular with visitors. The City of London is putting the bus on the road earlier than usual to accommodate our Convention needs. Please register **A.S.A.P.** as well.

"Deadly malaria on the run" - Deaths could be zero by 2015, says World Health Organization Toronto STAR
September 14 2011 Following are some points from the report.

Optimism is rising in the developing world with a 38% reduction in malaria deaths in the past 10 years but sadly in 2008 it still killed 863,000 people, 89% in Africa and 88% were children under 5 years old. The latest figures for 2009 show 781,000 people died, down from a million in 2000. It certainly says to JCI and other contributing agencies you are making a difference...keep the support coming.

Dollars to prevention and treatment including the distribution of insecticide-treated bed nets are cited as contributing factors to the success. The malaria campaign has shown a way of how to do effective aid with business people using business methods to run the campaign, asking for returns on money, setting deadlines and asking for efficiencies and transparency. The Senators and friends of the Canada JCI Senate are proud to support and actively participate in this enormous challenge, continuing to make the world a better place by living the Jaycee Creed.


It was lovely to meet you last week at the Wardroom.
