INSTRUCTIONS FOR COMPLETION OF THE APPLICATION

1. Complete and return the International Student Application along with a non-refundable fee of \$100.00, in check or money order made payable to 'Timothy Christian School'.
2. Send the following:
 - a. Copies of the student's most recent official school transcript, birth certificate, passport and immunization records in English.
 - b. Letter of recommendation from the student's teacher in English.
 - c. A recent bank statement to demonstrate that you can financially support the student for the school year (10 months) while they are living in America. This document should be certified by your bank in US dollars.
 - d. SSAT, TOEFL Jr. or TOEFL test results in English.
3. If student meets the requirements above, the applicant is interviewed via SKYPE by the TIP Coordinator and/or the School Superintendent/ Administrator.

STEPS AFTER ACCEPTANCE

1. Payment of the I-20 International Student Administration Fee of \$850.00.
2. An acceptance package with an I-20 will be mailed to you.
3. All forms must be completed and returned to Timothy Christian School.
4. If a visa is NOT received, we will refund \$600.00 of the International Student Administration Fee.

STEPS AFTER RECEIVING VISA

1. Send a copy of your Visa to our school along with the balance of the non-refundable registration fee of \$210.00 in a money order, payable to "Timothy Christian School".
2. U.S. Medical Insurance coverage is required. Timothy Christian School will provide information needed to apply for your medical coverage.
