Board of Directors:

The Shareholders are required to elect a Board of Directors as the corporate body that is responsible for the day-to-day management of the Corporation's business. Under Ohio law, there must be a minimum of 3 persons on the Board, unless the Corporation has less than 3 Shareholders. In that case, there must be at least as many persons on the Board as there are Shareholders. If this is a professional corporation, all of the members of the Board of Directors must be properly licensed to provide the professional services in which the Corporation is engaged.

Officers:

The Board of Directors elects the Officers of the Corporation. Ohio law requires that the Corporation have at least a President, Secretary and Treasurer. Most Corporations also elect a Vice President to serve in the absence of the President. You can also have other officers with special duties, such as a Chairman of the Board or "assistant" officers in each category. It is usually best to have different persons serve as President and Secretary because sometimes Ohio law requires the signature of both Officers and stipulates that they must be different persons. If this is a professional corporation, it is advisable, but not required, that all of the Officers be properly licensed to provide the professional services in which the Corporation is engaged.
