

This form is to be used if you are applying for an exemption from the logbook requirement that requires the completion of at least 100 hours of supervised driving in a car on a road during a three year period (**on-road driving experience**) before you are eligible to apply for the grant of a class C P1 provisional licence.

You may be eligible if you meet at least one of the following requirements:

1. Unavailability of a car to drive on a road

You are able to prove that a car is not reasonably available to you to enable you to complete your 100 hours of supervised on-road driving experience.

supervised driving is driving under the direction of a supervisor.

2. Unavailability of a person to be a supervisor You are able to prove that a supervisor is not reasonably available to you to enable you to complete your 100 hour

available to you to enable you to complete your 100 hours of supervised on-road driving experience.

A **supervisor** is a person who:

- a. directs the driving of a vehicle by you
- b. if the vehicle you are driving has passenger seating capacity-the person sits next to you while directing your driving
- c. holds an O type licence for a class C vehicle
- d. has held the licence for at least one year.

3. Limited access to road network

You are able to prove that:

- a. you live in an area with a limited road network that prevents you from obtaining driving experience in a variety of road and traffic conditions
- b. there is no significant benefit for you to satisfy the logbook requirement by driving a car on the road network
- c. there is no reasonable likelihood of you moving from the area or having an opportunity to drive a car in an area with a diverse road network.

A **limited road network** may be regarded as being a group of roads of the same kind, for example, an island with a single road around the island.

A **diverse road network** may be regarded as being a group of roads of different kinds, for example, single or double lane roads, intersecting roads.

Additional information

The lodgement of this application does not guarantee it will be approved. Your traffic history will be considered. Your application cannot be considered at the time of lodgement. It must be forwarded for consideration. You will be advised of the outcome.

If your application is approved, you will be required to hold your class C learner licence for at least two years during the three year period before applying for your class C P1 provisional licence.
