Advance Purchasing –

Payment of the deposit will secure the semen for the purchaser upon its arrival in Australia. The semen will be delivered to Gene Movers, Bacchus Marsh free of all fees and charges.

On payment of the balance of the purchase price the semen will be available for delivery to the purchaser, at their expense. You will be notified and freight arrangements should be organized at this time.

All pre-purchased semen will be available for delivery ex Gene Movers by 30/09/2015 at the latest. In the event the semen has not been delivered to Australia and cleared customs by this date the purchaser is entitled to a full refund of the deposit monies paid. We make every effort to meet our delivery date.

Purchasing Semen in Stock –

The semen is stored at and delivered from: Gene Movers P/L, 8 Station St., Bacchus Marsh, 3340

The semen will be insured and delivered to the purchasers nominated delivery address. The purchaser agrees to pay the following costs prior to delivery:

1. All semen purchase costs
2. All transport and handling charges as quoted below. Semen can be collected directly from Gene Movers if you wish. An upfront handling and processing fee will be charged for this dispatch.

Freight –

\$250 within Victoria; \$280 South Australia; \$330 NSW and \$390 Queensland and Western Australia. **Insurance, with an excess, is extra and must be requested** – ask EFF for details.

Please Note –

The transport container must be returned within 48 hours of semen delivery. The vapour shippers used are not supplied for or suitable for long-term storage of the semen. The purchaser needs to ensure they or their veterinarian has an appropriate means of storing the semen on receipt. Gene Movers will charge a late fee if the tank is not returned promptly. EFF is not responsible for the loss of semen once the tank has left Gene Movers (see above for insurance). Make sure your Veterinarian is aware that you have organized for frozen semen to be shipped to them.

1. This contract is for stallions that are sold without usage restrictions as per the stallions' page
2. This semen is supplied for the express purpose of creating equine pregnancies from owners mares
3. **Ownership of the semen is not transferable**
4. As allowed under the stallion's conditions, EFF will supply as many service certificates as the purchaser achieves pregnancies with the semen supplied. Such certificates will be supplied on receipt of a completed artificial insemination certificate from the inseminating veterinarian. A charge of \$30 per certificate applies for the second and subsequent pregnancies from a dose supplied.
5. All veterinary charges in respect of the mare/s are the responsibility of the purchaser
6. **All payments are to be made to "EFF Trust Account", Bendigo Bank – Benalla branch, BSB 633-000 A/c No. 126050053 prior to semen dispatch. Please fax or email a copy of the transfer or deposit slip.**
