

MEASURE 17.58

BALLOT TITLE: Josephine County Genetically Engineered Plant Ordinance.

QUESTION: Shall Josephine County adopt and enforce a ban on any plants whose DNA has been altered by technological means?

SUMMARY: Josephine County does not currently regulate the planting or growing of genetically modified or genetically engineered plants. This measure would prohibit the planting or growing within the County of any plant whose DNA has been altered by technology. The measure makes certain exceptions for medical research and educational institutions. The measure would authorize the County to use a Code Enforcement Officer to enforce the ban. Persons who violate the ordinance by knowingly or negligently allowing such growth could be subjected to abatement and remediation costs. The measure allows a twelve-month transition period away from genetically engineered plants for those persons who now grow them. The measure would allow confiscation and destruction of plants that have been genetically altered if contamination was occurring. Anyone who now grows genetically engineered plants would be required under this measure to notify the County Code Enforcement Officer of that fact within thirty days of the adoption of this measure. Anyone accused of growing genetically engineered plants would have fifteen days to provide evidence that the plants are not modified.

county could confiscate and destroy those plants as well, in accordance with established practice of due process.

After the effective date of this ordinance, the code enforcement officer is required to make reasonable efforts to inform everyone engaged in farming operations that all genetically modified or engineered plants are banned. Any person growing genetically modified or engineered plants at the time this ordinance becomes effective would be allowed twelve months to transition away from such plants and begin growing natural plants. After that time, any genetically modified or engineered plants found growing in Josephine County would be subject to confiscation and destruction.

This ordinance would allow the county to recover from the growers of genetically modified plants the costs of confiscation, destruction, and the remediation of any damages associated with the cultivation of the plants, including contamination of other, natural plants. In addition to county enforcement, private citizens may undertake to assert rights under the ordinance and may seek either injunctive or compensatory relief in the courts.

This ordinance does not impose any tax. It contains no provisions to raise or increase revenue. This ordinance would take effect upon approval of the voters.

Explanatory Statement:

Passage of this ordinance would ban any plant in Josephine County whose DNA has been altered by technological means.

Josephine County does not currently regulate the planting or growing of genetically modified or genetically engineered plants. This measure would prohibit the planting, propagation, growth or cultivation of any plants whose DNA has been genetically altered or genetically engineered.

Enforcement of this ordinance would be up to the county and to a code enforcement officer appointed or designated by the county. The code enforcement officer would be authorized to obtain search warrants if probable cause exists to believe that genetically modified or genetically engineered plants are present on land in Josephine County. Under the authority of the warrant, the officer could then take samples of plants to determine whether they are genetically modified or engineered. If the plants are genetically modified or engineered, the county could confiscate and destroy the plants. If the plants had contaminated other plants on adjoining land, the

THIS ORDINANCE WILL BE ADOPTED IF MEASURE 17.58 IS APPROVED BY THE VOTERS

Section 1. Title

This Ordinance shall be known as the Josephine County Genetically Engineered Plant Ordinance

Section 2. Purpose and Findings

- (A) The purpose of this Ordinance is to:
- a. Maintain and protect seed sovereignty and local control, free from outside corporate interests and unnecessary and overreaching preemption by the state and federal governments, of this County's agriculture, environment, public health, economy and private property rights as they pertain to genetic contamination from genetically engineered plants;
 - b. Prohibit any person, corporation or entity from propagating, raising, or growing genetically engineered plants in Josephine County; and
 - c. Enable Josephine County to enforce the genetically engineered plant ban and recover the costs of such enforcement.
- (B) This Ordinance supports the health, welfare and economic viability of the citizens of Josephine County, who desire to:
- a. Maintain and protect their inherent sovereign right to grow crops from natural seeds, in order to sustain their families and communities as they have already successfully done for generations;
 - b. Protect the County's agriculture, environment, public health, economy and private property from the physical, environmental and monetary damages linked to genetically modified organisms; and
 - c. Support the right to farm and garden in this County, as the citizens of Josephine County assert that the propagation, cultivation, growing and dispersal of genetically modified organisms are not reasonable or prudent farming practices and instead threaten the health, welfare and economic viability of that inherent right to farm and garden.

Section 3. Definitions.

- (A) "DNA" means "deoxyribonucleic acid," which is the genetic material that is present in every cell of an organism and is the "blueprint" for the organism's development.
- (B) "Genetic contamination" means the dispersal or spread of altered genetic information from genetically engineered organisms into the genomes of organisms in which such genes are not present in nature, such as by cross-pollination.
- (C) "Genetically engineered" or "genetically modified" means modification of living plants and other organisms by genetic engineering, and "genetically modified organisms" or "GMOs" means any living organism that possesses a novel combination of genetic material produced through the use of modern biotechnology techniques. Examples of genetic engineering and modification include, but are not limited to: altering or amending DNA using recombinant DNA technology such as gene deletion, gene doubling, introducing a foreign gene, or changing the position of genes, and includes cell fusion (including protoplast fusion), microencapsulation, macroencapsulation, gene splicing,) or hybridization techniques that overcome natural physiological, reproductive or recombination barriers, where the donor cells/protoplasts do not fall within the same taxonomic species and in a way that does not occur by natural multiplication or natural recombination. "In vitro nucleic acid techniques" include but are not limited to recombinant DNA or RNA techniques that use vector systems and techniques involving the direct introduction into the organisms of hereditary materials prepared outside the organism such as microinjection, macro-injection, chemoporation, electroporation, microencapsulation and liposome fusion, and any other technology or technique that results in an organism that contains genes from more than one species, or genes that are not naturally occurring. For purposes of this Ordinance, genetically engineered or modified organisms do not include organisms created by traditional selective breeding, fermenting, conjugation, normal in vitro fertilization or hybridization, or to microorganisms created by moving genes or gene segments between unrelated bacteria.
- (D) "Natural seeds" or "natural organisms" means seeds or organisms that do not possess a novel combination of genetic material obtained through the use of modern biotechnology and have not been genetically modified or engineered. Natural seeds or organisms include those seeds or organisms created by traditional selective breeding or hybridization methods.
- (E) "Organism" means any living thing.

Section 4. Reservation of Authority to Regulate Genetically Modified Organisms.

Josephine County hereby reserves the authority to regulate genetically modified organisms. This authority is construed to allow regulations and amendments, or delayed provisions, implementation, or enforcement of this law without limitation in time. Future laws that may preempt local regulations of genetically modified organisms, or any future regulation or amendments occurring under the authority provided by this Ordinance, shall not be construed to retroactively apply to affect the authority in this ordinance.

Section 5. Prohibition.

It shall be unlawful for any person, corporation or other entity to:

- (A) Propagate, cultivate, raise, or grow genetically modified organisms in Josephine County, or to knowingly or negligently allow such activities to occur on one's land, except as provided in Section 6 below.
- (B) Intentionally or negligently cause or allow any genetically modified organisms or materials from within or outside of the jurisdiction of Josephine County to substantially enter, drift or be dispersed into and within Josephine County, in such a way as to risk genetic contamination of natural organisms within the jurisdiction of Josephine County. Josephine County may enforce such violations to the extent possible pursuant to applicable laws.

Section 6. Exceptions to Prohibition.

- (A) State or federally licensed medical research institutions, medical laboratories, or medical manufacturing facilities engaged in licensed medical production, or medical research involving genetically modified organisms are exempt from this Ordinance provided that such activities are conducted under secure, enclosed indoor laboratory conditions with the utmost precautions to prevent release of any part of genetically engineered organisms, especially but not limited to pollen, to the outside environment.
- (B) Educational or scientific institutes, including but not limited to Oregon State University Extension, working with genetically engineered organisms are exempt from this Ordinance provided that such activities are conducted under secure, enclosed indoor laboratory conditions with the utmost precautions to prevent release of any part of genetically engineered organisms, especially but not limited to pollen, to the outside environment.
- (C) Any institution listed in (A) or (B) above that intentionally or negligently allows release of any part of genetically engineered organisms into the outside environment is in violation of this Ordinance and subject to enforcement as set forth herein.

Section 7. Code Enforcement Officer, Disclosure, Phase-In and Transition.

- (A) Code Enforcement Officer. The Josephine County Board of Commissioners may designate one or more persons to administer and enforce the provisions of this Ordinance, herein referred to as the Code Enforcement Officer.
- (B) Upon enactment, the Code Enforcement Officer shall make reasonable efforts to provide initial notification of this ordinance to farming operations within Josephine County.
- (C) Every person, corporation or entity cultivating, raising and growing genetically modified organisms, including those institutions set forth in Section 6 above, must disclose to the Code Enforcement Officer within thirty (30) days of enactment of this Ordinance the location and description of existing or planned genetically engineered crop(s) or materials involved, in order to develop a transition plan to phase out such organisms.
- (D) The Code Enforcement Officer shall make reasonable efforts to notify farming operations of technical assistance and resources that may be available to assist with the transition from genetically engineered to natural organisms.
- (E) Farming operations with genetically engineered crops shall have up to twelve (12) months from the date of enactment to phase out planting and harvesting of genetically modified organisms.
- (F) Actions required of the Code Enforcement Officer in this section are intended to assist farming operations with compliance and assistance. Failure to receive notification does not waive or otherwise affect requirements for compliance with the provisions of this Ordinance.

Section 8. Enforcement and Remedies.

- (A) Notification. The Code Enforcement Officer shall notify any person, corporation or entity that may be in violation of this Ordinance that any organisms in violation of this Ordinance are subject to confiscation and destruction, in accordance with due process.
- (B) Response. Any person, corporation or entity that receives notification under subsection (B) shall have fifteen (15) days to respond to such notification with evidence that such organisms are not in violation of this Ordinance. Time for response may be shortened upon a showing of current, ongoing and/or imminent harm or risk of genetic contamination.
- (C) If the notified party does not provide such evidence, or if there is probable cause to believe genetically engineered plants are present, the Code Enforcement Officer may take necessary actions required by law (such as obtaining a search warrant) to obtain access to the property and obtain samples of materials, in accordance with due process.
- (D) Determination. Upon receipt of any evidence under subsection (D), the Code Enforcement Officer shall consider such evidence and any other evidence that is presented or which is relevant to a determination of such violation. The Code Enforcement Officer shall act in good faith to make such determination as soon as possible, and before any genetic contamination may occur. If genetic contamination has already occurred or cannot be prevented before the determination is completed, Code Enforcement Officer shall make efforts to abate and prevent further contamination.
- (E) Remedies. In addition to any remedies and penalties provided that may be available by law, the following remedies and penalties may be imposed:
 - a. Any organisms that are the subject of violation of this Ordinance may be confiscated, quarantined, and destroyed before any genetic contamination may occur. If genetic contamination has already occurred, the contaminated organisms may be confiscated, quarantined, and destroyed, in accordance with due process.
 - b. Administrative and abatement costs associated with the confiscation and destruction of organisms may be imposed on responsible parties (namely the person(s), corporation(s) or other entities responsible for the violation). If contamination has already occurred, costs for remediation of contamination may be imposed on responsible parties.
 - c. In imposing administrative and abatement costs on the responsible parties, the Code Enforcement Officer shall take into account the amount of actual and reasonably foreseeable damage, and the degree of willfulness, reckless disregard or negligence of the person, corporation or entity involved.
- (F) Any individual citizen of Josephine County shall have standing to assert any rights secured by this ordinance that have been violated or are threatened with violation, and may seek injunctive and/or compensatory relief from a court of competent jurisdiction.

Section 9. Severability.

To the extent any provision of this Ordinance is deemed invalid by a court of competent jurisdiction, such provision will be removed from the Ordinance, and the balance of the Ordinance shall remain valid.

ARGUMENT IN FAVOR

GMO risks, and a silver lining:

What do GMO health studies from outside the U.S. say? A study in France showed that Bt toxin kills human kidney cells. A study in Egypt found abnormalities in livers, kidneys and spleens of rats fed on Bt corn. A study in Norway found high levels of glyphosate (Roundup herbicide) and its breakdown products in GMO soy. A study in Denmark ties glyphosate to human male infertility. A study in Brazil found 32 differently expressed proteins between Mon 810 (GMO) corn and equivalent non-GMO corn. (source: Institute for Science in Society www.i-sis.org.uk).

The U.S.D.A. designation of "substantial equivalence" has allowed GMO's to bypass more thorough testing required of "new" foods. Current testing requirements are inadequate to assess the safety issues inherent in genetic modification. Other nations require more thorough testing, or tests not funded by the patent holder who stands to benefit. These places seem to be moving away from, rather than towards, accepting GMO crops.

Genetic engineering is a process, not a product. Some GMO's may prove beneficial, while others may cause harm. Genetic modification can cause unpredictable and uncontrollable changes in the modified plant or animal and its offspring.

GMO's are not going away. Bigger farms, thousands of acres, are possible using pesticide tolerant plants. That's not us. The Rogue Valley has smaller farms. We do have a dedicated core of specialty farmers able to produce the highest quality food, wine, seed and other products.

The demand for GMO-free food is not going away either. It is a myth that 17-58 primarily benefits organic farmers. As GMO-free becomes increasingly scarce, a premium price for all Rogue Valley products will follow. This is the silver lining.

New GMO plant types are being released each year. Soon, restricting them from our valley will be impossible. Now is the time to say "not here" to GMO crops.

ARGUMENT IN FAVOR

VOTE YES on MEASURE 17-58

- Protect family farms, encourage economic growth in the region, increase land values, and preserve variety and beauty of our forests, rivers, and farm lands.

SAFEGUARD FARMS AND FAMILIES

- GE crops can cross pollinate and contaminate other farmer's crops, causing huge losses for non-GE farmers. This type of trespass has cost local farmers thousands of dollars in lost income. Farming methods used to grow GE crops require massive amounts of toxic pesticides and often leave behind superweeds.
- In a Policy Statement, the American Academy of Pediatrics warns that pesticide exposure in children can lead to cancer, lower brain function, and behavioral problems (12/10/2012).
- GMOs are linked to many health problems, including digestive issues, diabetes, autoimmune disorders, and cancer, according to the American Academy of Environmental Medicine (Position Paper, May, 2009).

BOOST LOCAL ECONOMY

- **Measure 17-58** will protect Josephine County from pollution caused by heavy pesticide use and cross contamination, and provide economic benefit. Because of international bans and restrictions, there is an increasing consumer demand for **GMO-free** food production, often for premium prices.
- **Josephine County** stands ready to become a premier food and seed producer in Oregon and the West Coast, meaning more jobs and more small businesses, and increasing land values.
- Other counties that have passed similar measures have seen huge increases in agricultural income, in some cases, up to **700%** increase in Agricultural value within 10 years.
- **No new taxes** are created by this measure. Counties with similar measures have had **zero**-to-negligible **cost** for implementation.

KEEP DECISIONS LOCAL

- This measure affirms the rights for Josephine County residents to keep control of local agriculture.
- GMO and GE refer to the process of taking a gene or genes from one species and forcing it into DNA of other (unrelated) species. Genetic Engineering mixes and matches between plant, animal, human, insect, bacteria and viruses, creating new organisms that could never occur in nature. GMOs are NOT hybrids.

ARGUMENT AGAINST

Measure 17-58 hurts Josephine County farmers and taxpayers

The Oregon Farm Bureau Federation was created to defend the rights of farmers, and represent their best interests before the public and government.

Measure 17-58 is NOT in the best interests of farmers, nor the taxpayers of Josephine County.

Measure 17-58 may have a damaging, long-term impact on the future of agriculture in Josephine County. The USDA Advisory Committee on Agriculture in the 21st Century attests to the benefits of technology and innovation that farmers need today and in the future.

Whether or not they choose to plant genetically engineered crops, grow organic plants, or even seed their fields by the lunar calendar, that is their decision to make, not that of a very small minority of farmers looking to increase their already notable profit margin at the expense of a much larger community. I would also oppose a measure that banned any other method of farming as well.

The Farm Bureau supports freedom of choice for farmers, and defends Oregon's Right to Farm and Forest Law, which protects our local agricultural community from misleading and dangerous measures, just like 17-58.

Measure 17-58 is:

- Bad policy for agriculture and the county economy.
- An unfair limitation on farmers' rights.
- Likely to make local farmers unable to compete in the marketplace.
- Likely to be challenged in court as violating the state's Right to Farm and Forest Law.
- An intrusion on private property rights
- Unnecessary.

Also, voters must consider costs to taxpayers. The Jackson County Administrator conducted a thorough analysis on a similar ballot measure and tallied annual costs to the county to be more \$219,000!¹ With Josephine County's budget in even worse shape than Jackson County, it's clear that passage of this measure would be a budget buster and bad policy.

Vote No on Measure 17-58.

ARGUMENT AGAINST

Measure 17-58 Will Be a Financial Disaster for Josephine County

The proposed ordinance banning the very small number of genetically modified crops grown here could cost county government and local taxpayers hundreds of thousands of dollars in start up and perhaps millions in ongoing enforcement expenses, according to Jackson County's analysis of the cost of a similar measure in that county.¹

Possible "field clean up" costs could easily exceed enforcement costs, and that's very bad news for local property owners.

A Cost We Can't Afford

Josephine County's finances are already stretched thin. Recent cutbacks have left county managers making tough decisions that are near and dear to us all. Local and valuable programs and services are already at risk. Passage of 17-58 likely means more difficult cutbacks.

Landowners found in violation of this measure could face abatement costs that could put their land into foreclosure. If they can't pay for the abatement, then the county will be stuck with the bill. These are costs that our county and local residents cannot afford.

Measure 17-58 is Misleading

1. Proponents say there are no county costs - and yet, there are significant county expenses that we cannot afford.
2. Proponents suggest banning genetically modified organisms will improve local land values. In fact, the practical impact of this measure may likely mean future values decline as access to new technology and innovation that farmers need, is not allowed here, in turn limiting interest and investment.
3. A ban likely subjects the county itself to expensive and costly litigation, as the measure is certain to be challenged in court.

I urge Josephine County voters to say NO to Measure 17-58.

ARGUMENT AGAINST

No on 17-58 My Home, My Property, My Rights!

I urge you to vote No on Measure 17-58. This proposal is a dramatic intrusion on the rights of private property owners here in Josephine County. The determination to either farm my land or lease my farmable land to a third party is, and should remain, my own choice. To propose a measure, such as 17-58, that purports to limit what I farm, how I farm, which production practices I can use, and to whom I can lease or rent my land, is a significant over-extension of unnecessary government regulation.

Given the struggling economic realities of Josephine County, it makes little or no sense to limit land use, or agricultural production for the sole benefit of a small handful of individuals. It makes even less sense to support a proposal that could in fact decrease my own land values, or potential income and economic gain.

The County Administrator in neighboring Jackson County has also gone on record stating that enforcement of a similar ballot measure may cost more than \$200,000 per year.¹ While Jackson County's budget is bad, Josephine County's is even worse. The thought of spending any money to police farmers when we can't even afford to lock up criminals is mindboggling.

Our county government does not have the adequate financial resources needed to pay for this measure, and it is certainly not worth the intrusion on my rights as a property owner.

I urge you to **Vote No on Measure 17-58**.

The Scientific Consensus on GMOs

As director of the International Biotechnology Program at the University of California Davis and an expert in biotechnology for over 25 years, I urge you to vote **No on Measure 17-58**. It's a misguided effort to ban genetically modified crops, despite scientific consensus that GMOs are safe and can benefit our food supply.

GMOs are safe:

- An overwhelming majority of scientists, medical experts, & eminent organizations have concluded that crops produced using modern biotechnology techniques are safe.
- An estimated 2 trillion meals containing GM ingredients have been eaten around the world over the last 16 years without a single substantiated case of ill-health.
- The World Health Organization has said that: "No effects on human health have been shown as a result of the consumption of such foods by the general population in the countries where they have been approved."¹

GMOs produce important benefits:

- A potato has been developed in Idaho with an 80% reduction in acrylamide, a potential carcinogen produced when some foods such as potatoes are cooked.
- Omega-three fatty acids have been increased in soybean oil to provide a land-based source of the oil that has been shown to protect against cardiovascular disease and cancer and improve mental acuity.
- Golden rice, which provides beta carotene in the grain, can protect against vitamin A deficiency which can result in blindness, and development and immune disorders. This disease of poverty kills as many as 2.8 million people annually, mostly women and children under 5.

- The ordinance would likely be challenged in court with taxpayers footing the legal costs.

In fact, there have been more than 1,700 peer-reviewed studies over the past decade and none points to higher risks. MEASURE 17.59

BALLOT TITLE: Five Year Levy for Jail and Youth Services and Detention.

QUESTION: Shall County impose \$1.19 per \$1,000 assessed value for jail beds and youth treatment services for five years beginning 2014/15?

This measure may cause property taxes to increase more than three percent.

SUMMARY: Passage of this measure would provide funding for Josephine County to:

Provide the Sheriff and local law enforcement agencies with increased adult jail beds to hold persons accused or convicted of crimes until their cases are completed or sentences served; and Provide counseling, secure treatment, detention and shelter services to community youth offenders and "at-risk" juveniles.

The revenue from this measure would be restricted and used only for funding increased adult jail bed capacity and for youth treatment counseling, secure treatment, detention and shelter services.

This tax would automatically end after 5 years. For a home valued at the Josephine County 2013 median residential property value of \$141,585, the annual tax payment would increase by approximately \$168.41 per year or \$14.03 per month.

The proposed rate will raise approximately \$7,570,670 in 2014-2015; \$8,124,780 in 2015-2016; \$8,368,524 in 2016-2017; \$8,619,579 in 2017-2018; and \$8,878,167 in 2018-2019.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate.

Explanatory Statement:

Josephine County has experienced reduced revenue from federal timber lands. As a result, the County has reduced the number of Sheriff's Office patrol deputies and has reduced the number of corrections deputies stationed in the county adult jail. The reduction in jail staffing has reduced the number of inmates the adult jail can hold. In the same way, juvenile detention services, counseling services, and treatment and shelter services for juveniles have been reduced. This measure would provide dedicated funding for the Josephine County adult jail, juvenile detention and treatment, and juvenile shelter care facilities.

The revenue from this measure would allow the Sheriff's Office to increase the number of adult jail beds and add jail staff members, so that the adult jail could house a larger number of persons accused

of or convicted of committing crimes. It would allow the addition of staff persons to provide counseling for juvenile offenders and "at-risk" juveniles, as well as providing treatment, detention and shelter care for juveniles.

If this measure passes, it would provide stable funding for the adult jail and for youth services and detention for a period of five years. The measure would allow Josephine County to collect taxes at the specified rate for a period of five years with the revenue from the measure dedicated for adult jail and youth services and detention only, and the funds could not be used for any other purpose.

At \$1.19 per \$1,000, for every \$100,000 of a property's assessed value, the tax would cost \$9.92 per month or \$119.00 per year. The approximate tax increase for a home valued at the median property value in Josephine County, with an assessed value of \$141,585, would be \$168.41 per year, or approximately \$14.03 per month. The levy would be for five years beginning in 2014.

The proposed rate will raise approximately \$7,570,670 in fiscal year 2014-2015; \$8,124,780 in fiscal year 2015-2016; \$8,368,524 in fiscal year 2016-2017; \$8,619,579 in fiscal year 2017-2018; and \$8,878,167 in fiscal year 2018-2019; for a total of \$41,561,720.

MEASURE 17.60

BALLOT TITLE: Three Year Levy for Animal Shelter and Animal Control.

QUESTION: Shall Josephine County impose \$0.08 per \$1,000 assessed value for Animal Control and Animal Shelter for three years beginning 2014-2015?

This measure may cause property taxes to increase more than three percent.

SUMMARY: Approval of this measure authorizes a three-year levy of \$0.08 per \$1,000 of assessed value beginning Fiscal Year 2014-15 to provide funding for animal shelter and animal control services for all areas of Josephine County.

The Josephine County Animal Shelter provides food, care, and temporary shelter for homeless dogs, cats, and other animals impounded under law. The shelter also provides animal adoption services.

Josephine County Animal Control investigates cases of animal abuse, neglect, hoarding, and abandonment. Animal control enforces state and local laws that regulate dogs running at large and dogs that are a public nuisance or danger.

The funds generated from this tax will be restricted to funding Animal Shelter and Animal Control Services. For a home valued at the Josephine County median residential property value of \$141,585, the annual property tax payment would increase by approximately \$11.33.

The proposed rate will raise approximately \$508,953 in 2014-15; \$546,204 in 2015-16; and \$562,590 in 2016-17.

The estimated tax cost for this measure is an ESTIMATE ONLY based on the best information available from the County Assessor at the time of the estimate.

Explanatory Statement:

The Josephine County Animal Shelter provides food, care and temporary shelter for an average of 1,750 homeless dogs, cats, and other animals each year. The shelter also provides adoption services for homeless animals. In calendar year 2013 the shelter adopted out approximately 720 animals.

Josephine County Animal Control investigates cases of animal abuse, neglect, hoarding and abandonment. Animal Control officers enforce state and local laws regulating dogs running at large, and dogs that are or may be dangerous or a public nuisance. That includes dogs that chase or attack livestock. Both the Animal Shelter and Animal Control are supervised by the Josephine County Public Health Department.

If this measure passes, it would provide stable funding for the Animal Shelter and Animal Control field services for a period of three years. The measure would allow Josephine County to collect taxes at the specified rate for a period of three years with the revenue from the measure dedicated for Animal Shelter and Animal Control field services only, and the funds could not be used for any other purpose.

At \$.08 per \$1,000, for every \$100,000 of a property's assessed value, the tax would cost 67 cents per month or \$8 per year. The approximate tax increase for a home valued at the median property value in Josephine County, with an assessed value of \$141,585, would be \$11.33 per year, or approximately 94 cents per month. The levy would be for three years beginning in 2014.

The proposed rate will raise approximately \$508,953 in fiscal year 2014-2015; \$546,204 in fiscal year 2015-2016; and \$562,590 in fiscal year 2016-2017; for a total of \$1,617,397.

The estimated tax cost for this measure is an estimate only based on the best information available from the County Assessor at the time of the estimate.

Shelter volunteers have even traveled out-of-state to find adoptive homes. In 2013, the Shelter adopted out over 720 animals. Living animals require care 365 days of the year!

The levy funding will go DIRECTLY to run the Animal Shelter and Animal Control; provide food, shelter, and care for the animals; provide more outreach to get dogs licensed (a State law); spay/neuter more animals to reduce the unwanted pet population; provide community education on pet care and training; and respond to incidents of animal hoarding, cruelty complaints, and animal-related neighbor conflicts.

MEASURE 17.61

BALLOT TITLE: Advisory Question on Timber Salvage and Replanting after Wildfire.

QUESTION: In your opinion, should federal agencies maximize salvage harvesting of dead and dying timber and replant areas damaged by wildfires?

SUMMARY: In 2013, large areas of federally owned timberlands in Josephine and neighboring counties burned due to wildfires. The fires left many stands of timber with trees that are dead or dying, but which may have economic value if harvested within a reasonable time. Federal land managers are currently considering whether to authorize the harvest of such timber, and whether the harvested areas would or would not be replanted. The Board of County Commissioners is soliciting opinions on this topic from County electors.

The Board of County Commissioners has placed this advisory question on the ballot to determine whether a majority of voters want federal agencies to maximize salvage harvesting of dead and dying timber and replanting of the areas damaged by wildfires.

The outcome of the election on this advisory question will not be binding, but will provide information to the Board. Neither the voters nor the Board is in a position to require federal agencies to authorize such harvesting. The voters and the Board can make recommendations and offer opinions.

Explanatory Statement:

Josephine County residents are affected by federal policy decisions regarding federally owned timberland in Josephine County. The Board has determined that the electors of Josephine County should have the opportunity to contribute opinions regarding federal policy matters that have an economic impact on Josephine County residents.

A large portion of the lands affected by the recent wildfires are O&C lands. In 1937, Congress passed The O&C Lands Act, which placed management of the lands under the United States Department of the Interior, and directed that timberlands be managed "...for permanent forest production, and the timber thereon shall be sold, cut, and removed in conformity with the principle of sustained yield for the purpose of providing a permanent source of timber supply, protecting watersheds, regulating stream flow, and contributing to the economic stability of local communities and industries, and providing recreational facilities..." (43 U.S.C. §1181a).

Prior to the passage of the act, no provisions for reforestation existed. The O&C Lands Act embraced the new principles of "sustained yield" requiring that harvested areas be reforested. The intent of the act

was to provide a future source of timber which would contribute to local economic stability. It was assumed that providing this continuous source of timber through reforestation and regulated harvest would also protect watersheds and help regulate stream flows.

The O&C Lands Act also required that 50 percent of the revenue generated from management of the lands be returned to the 18 O&C counties, including Josephine County.

In order to offer an opinion to the federal government on the management of these lands, the Board of County Commissioners is asking the voters of Josephine County to express their opinion on this question: Should the federal land managers authorize the harvesting of salvage timber damaged by fires, and should the land affected by such harvest be replanted for future harvest of timber?

The answer to this question is advisory only, and will not impose any requirement on the federal government. It will, however, provide to the federal government an expression of the opinion of the voters of Josephine County.

The answer to this advisory question will have no binding effect.

This is a request from the Board of County Commissioners for information from the community. The question is an opportunity for the community to express opinions. The Board of Commissioners will use the responses to this question to formulate policy.

This measure will not cause property taxes to increase.
