

WEDDING PHOTOGRAPHY CONTRACT

BOOKING INFORMATION

To reserve your wedding date, we require a \$200 Retainer Fee plus a signed wedding contract. In the event of a postponement, cancellation, or day/time change of the wedding, or if the photography services are cancelled for any reason, the Retainer Fee is non-refundable or transferable. Travel fees including, but not limited to, airfare and hotel reservations for weddings outside of the Denver metro area are due upon signing of the contract and are also non-refundable, non-transferable, and reservations may not be cancelled if the wedding or wedding photography coverage is cancelled, postponed, or if there is a day/time change of the wedding. If the wedding or wedding photography services are cancelled or postponed 30 days or less from the actual wedding date, then payment in full will be required. Any payments made toward the balance of the wedding contract, including payment made towards Wedding Extras that are written in the contract, are non-refundable or transferable if the wedding or wedding photography coverage is cancelled, postponed or if there is a day/time change of the wedding. Half of the balance (half of the package, extras and sales tax, minus the \$200 retainer fee) is due 30 days prior to the wedding date. If this payment is not made 30 days prior to the wedding date, Creative Touch Photography is no longer liable to photograph the wedding or deliver the package contents, including, Wedding Extras that were ordered. The remaining half of the balance is due on the wedding date. If the final payment is not made on the wedding date, Creative Touch Photography is no longer liable to deliver the package contents, including, Wedding Extras that were ordered.

FINANCES

Our prices do not include Parker sales tax. In compliance with the Colorado Department of Revenue, products and packages that include products will be billed with sales tax. We accept cash, check, Visa, Mastercard and PayPal. The charges in this contract reflect Creative Touch Photography's current price list. Our prices are not guaranteed unless the products are written into this contract. Any orders placed will be billed at the prices in effect at the time the order is placed. Please note that we reserve the right adjust our prices periodically. All re-orders require a full payment of 100% a the time the order is placed. No part of any order, including link to online proofs, will be available until balance is paid in full.

STUDIO LIABILITES

The studio takes the utmost care with respect to the exposure, development, and delivery of photographs. However, in the event that the studio fails to comply with the terms of this contract due to fire, or other casualty, strike, act of God, or other cause beyond control of the parities, or due to the Photographer's illness or emergency, then the studio shall return the Retainer Fee and any payments received to the client but have no further liability with respect to the contract. This limitation on liability shall also apply in the event that photographic materials are damaged in the processing, lost through camera malfunction, lost in the mail, are stolen, or otherwise lost or damaged for any reason, the Studio/ Photographer shall not be liable for any amount in excess of the retail value of the client's order.

MODEL RELEASE/COPYRIGHT NOTICE

The studio reserves the right to use the file, negatives and/or reproduction for the purpose of creating samples, displays for publication in advertising, magazine or newspaper articles or other public relation purposes. The negatives/files shall remain the exclusive property of this studio unless otherwise agreed upon by the clients and photographer. It is illegal to copy or reproduce any of the Studio/Photographer's photographs elsewhere without the expressed permission of the Studio/Photographer. Violators of the Federal Law will be subject to its civil and criminal penalties.

PHOTOGRAPHY COVERAGE

The Studio/Photographer may substitute another photographer to take the photographs in the event of Photographer's illness or other emergency. In the event of such substitution, the Studio warrants that the photographer taking the photographs shall be a competent professional. The Studio/Photographer will begin their coverage at the designated time. It is the client's responsibility to make sure that any events they would like photographed are within the photographer's contracted time. The photographer is not responsible for any missed photographs requested due to timing or lack of missing subjects at the time of portraits taken. We are not responsible for clothing and other attire adjustments and cluttered locations. Please designate someone to look for photograph distractions (i.e. veil, dress, flower adjustments or picking up litter). We request that no other person (professional or amateur) will be taking pictures during our entire coverage. This includes, but is not limited to, other wedding vendors such as wedding coordinators, videographers, and DJ's. This interferes with our timing and exposures and may affect the outcome of your wedding coverage. In the event that a person or persons interfere with this clause, a warning will be given to the client. If the problem persists, our coverage will end immediately with no further liability to finish the coverage or deliver the package components and no type of refund offered.

PACKAGE COMPONENTS

The Studio/Photographer takes the utmost care with respect to the timing of receiving your wedding album and components of your wedding package. While trying to provide this service, the Studio/ Photographer requires the cooperation of the client. The client must attend to album orders and package components within 90 days after of the wedding. This includes, but is not limited to, choosing the images for the album. If album orders and package components are not attended to before 90 day time period, the order price is subject to the current price guide at the time the order is placed. If the client purchases an album, the client will be allowed up to two complimentary changes upon first viewing of the album design. Any changes made after the two will be billed at \$10 a change. If a CD was purchased separately or part of the package component, the CD will have a limited use license and will only be given in mid-resolution jpeg files. The images are to be used for personal printing and use for preservation. Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
