SPEAKERS

SESSION (TOOL) ONE: Your Survival Guide to the IRS' Higher Ed 403(b) Compliance Check

Presenters: Linda Segal-Blinn, ING & Daniel Gardner, IRS

Topic Summary: You have adopted your 403(b) plan document and identified those employees who are eligible to contribute to that 403(b) plan. If you are among the 300 public and private higher education institutions randomly selected by the IRS, you now will need to prove this - starting in April 2011, the IRS has launched a Compliance Check initiative to ensure that 403(b) plans sponsored by higher education employers extend participation in the 403(b) plan to all eligible employees.

The IRS Employee Plans Compliance Unit's webpage announces that the new "featured" project is the rollout of the universal availability questionnaire to Higher Education 403(b) plans. Be aware of potential compliance pitfalls to respond successfully to the Compliance Check.

SESSION (TOOL) TWO: The Value of a Healthy Culture: Achieving Results via a Healthy Campus Strategy

Presenters: Ruth Donahue & Penny Finch, Sibson Consulting, A Division of Segal

Topic Summary: Sibson found that a healthy and effective workplace achieves better health, absence, retention and safety outcomes. Sibson conducted a study of employers nationally to test its Healthy Enterprise maturity model and understand the impact strategies and practices have on driving outcomes such as health, absence, turnover and safety. Sibson's analysis of its nearly 300 survey respondents, including 71 higher education institutions, validates its maturity model and identifies a number of significant correlations that drive outcomes and program participation.

SESSION (TOOL) THREE: Healthcare Reform - What's On The Horizon?

Presenter: Lisa Collins Carlson, Gallagher Benefit Services, Inc.

Topic Summary: Discussion of Healthcare Reform including near term requirements for employer's sponsoring health plans (what employers need to do between now and 2014), any specific impact to universities, status of litigation (appeals and supreme court outlook), and 2014 requirements (individual and employer mandates).

SESSION (TOOL) FOUR: Developing an Effective Retirement Strategy During Uncertain Times

Presenter: Diane Short, TIAA-CREF

Topic Summary: It is always important to think about retirement goals and the plans we make to achieve them. During this uncertain economic period, it is even more important to focus on the steps we need to take to help ensure our future. This presentation will examine the impact of the recent economic downturn, explore what employers can do, and discuss how employees can manage their retirement income during volatile times. Directions

From Columbia ~ Take Hwy 63 south to Jefferson City. In Jefferson City turn right on 54 west. Follow 54 west about 50 miles to the Business 54 exit in Lake Ozark. At Lake Ozark, exit onto Business 54 (Bagnell Dam Exit). Go about 2 miles on Business 54 to 1st stoplight. Turn right at the stoplight onto State Rd. HH (Horseshoe Bend Parkway) for about 1.5 miles; then turn right on Carol Road. We are a half-mile down Carol Road on the left.

Travel time approximately 1 1/2 hours.

From Kansas City ~Take Hwy 50 east from Lees Summit to Tipton. At Tipton stoplight, take Hwy 5 south. Hwy 5 south will merge with Hwy 52. Go left on 52 east. Take 52 east to Eldon. At 2nd stoplight in Eldon, turn right. That will take you to Hwy 54. Turn right on 54 west. Follow 54 west about 9 miles. At Lake Ozark, exit onto Business 54 (Bagnell Dam Exit). Go about 2 miles on Business 54 to 1st stoplight. Turn right at the stoplight onto State Rd. HH (Horseshoe Bend Parkway) for about 1.5 miles; then turn right on Carol Road. We are a half-mile down Carol Road on the left.

Travel time approximately 3 1/2 hours. From the airport, take 435 loop south to Hwy 50.

From Springfield ~ Take I-44 east to Lebanon. At Lebanon, take Hwy 5 north (2nd exit) to Camdenton. At the stoplight in Camdenton, turn right onto Hwy 54 east. Take 54 east about 15 miles to the Bagnell Dam exit in Lake Ozark. Turn right at the stoplight onto Business 54(Bagnell Dam Blvd). Go about 2 miles on Business 54 to the next stoplight and turn left onto State Rd. HH (Horseshoe Bend Parkway) for about 1.5 miles; then turn right on Carol Road. We are a half-mile down Carol Road on the left. Travel time approximately 2 hours.

From St. Louis ~ Take I-70 west to Kingdom City. Exit onto Hwy 54 south(west). Take 54 south(west) 80 miles to Lake Ozark. At Lake Ozark, exit onto Business 54 (Bagnell Dam Exit). Go about 2 miles on Business 54 to 1st stoplight. Turn right at the stoplight onto State Rd. HH (Horseshoe Bend Parkway) for about 1.5 miles; then turn right on Carol Road. We are a half-mile down Carol Road on the left. Travel time approximately 3 hours.
