**Abstract** :This dataset contains case counts of asthma (ICD9-CM 493.0-493.9) and myocardial infarction (ICD9-CM 410) inpatient hospitalizations among Connecticut residents for the years 2000-2005. These data are stratified by year and month of admission, county of residence, age group, and gender.

**Purpose** :To provide data for the National Environmental Public Health Tracking Network consistent with the guidance for creating asthma and myocardial infarction inpatient hospitalization Nationally Consistent Data and Measures (NCDMs).

**Supplemental Info** :Data has been de-identified to protect patient confidentiality. Dataset contains 34,388 total observations. Asthma and myocardial infarction hospitalizations are selected based on primary discharge diagnosis coding.
