DIRECTIONS

Take I-465 towards the East side of Indianapolis. Take the 56th Street exit East (Exit 40). Continue East on 56th Street approximately one mile to Post Road. Turn North (left) onto Post Road. Turn East (right) onto 59th Street. The Garrison is on your left approximately one block down.
