Tags and Stickers will be mailed out beginning April 1st POOL SEASON IS COMING SOON! TAGS AND/OR 2007 STICKERS WILL BE REQUIRED FOR POOL USE. The Willowlake pool will open on Saturday, May 5, 2007 and will be open weekends only in May until Memorial Day. Aquatic Management will be handling pool management. Other than registration, feel free to contact them for any pool related questions, concerns, or to schedule pool parties at 281-446-5003. Please follow the following steps to register for the 2007 swim season:

#### POOL REGISTRATION PROCEDURES

- 1. Please make sure your account has a zero balance.
- 2. Fill out the enclosed registration form on page 5. List all family members residing in your home in need of pool tags and/or stickers. All information MUST be filled out especially the Emergency Contact and Medical Information. Failure to do so will delay processing.
- Mail the COMPLETED registration form to SCS Management Services, 7170 Cherry Park Drive, Houston Texas 77095.
   You can fax your form to 281-500-7174. PLEASE NOTE: YOUR REGISTRATION FORM MUST BE RECEIVED BEFORE JUNE 1.
- 4. Everyone 10 years and older must have a tag; and children under 10 cannot use the pool unless accompanied by an adult.
- Initial registration will be done entirely by mail/fax. Tags will not be available for walk-in registration until <u>after June</u> <u>1st</u>

#### LATE REGISTRATION

- Forms received as of June 1st will incur a \$10.00 processing fee.
- 2. Please keep your tags as they will be used for multiple years.
- 3. Lost tags can be replaced at a cost of \$1.00 per tag.
