- 1. If Lesmen's shall at any time repossess or utilize the services of a collection agency or attorney to retrieve or collect payment for the articles under the terms of this agreement, the renter will pay all costs and expenses of repossession and removal, collections and attorney services, and repossession of the equipment shall not extinguish any unpaid rentals due at the date of repossession.
2. The renter or authorized pickup person is responsible for verifying the equipment from Lesmen's to be in good working condition. The renter's credit card is being held as collateral on the equipment, and renter authorizes Lesmen's to charge the card for the articles if they are not returned and for any repair costs that were the result of misuse by the renter. Lesmen's is not responsible for misuse or pilot error of rental equipment. Rental equipment is not insured.
3. If the renter desires to extend this contract beyond the due date and time originally agreed upon, the renter will immediately notify Lesmen's of his/her desire and obtain Lesmen's approval and terms of the extension.
4. Lesmen's may, at its own discretion, report the property listed as stolen if it is not returned in (3) days of the date listed as "due date," and if conditions and circumstances indicate theft before that time.
5. Renter hereby agrees not to remove the said property from the state of New Mexico without obtaining written consent of Lesmen's or change place of residence or phone number without immediately notifying Lesmen's of the address or phone number.
6. Rental payments do not apply to purchase.
7. Rentals are due by 1:00 p.m. on the due date or renter pays a full day's rental for each day thereafter until rental is returned.
8. All cables and equipment must be kept clean and cables wrapped or there is a charge of \$40.00 charge for maintenance (Example: No tape on cables, mud or hay on speakers).
I, the renter, have read and understand the above terms. I also understand that my signature on this document makes me responsible for the full replacement value (plus tax) of the above listed items if they are lost, stolen or damaged.
9. To reserve a rental it must be pre-paid in full. A 50% restocking fee will be charged if cancelled 48 hours prior to rental, and your remaining deposit will be credited to your Lesmen's account "Not your credit card". No refunds within 48 hours of rental date.
