The prospectus supplement of said trust also listed DLI Mortgage Capital, Inc. as sponsor; and Ownit Mortgage Solutions, Inc. as one of the originators.

- 7. The chain of title under that Promissory Note should have been endorsed by Ownit Mortgage Solutions, Inc. originating lender to DLI Mortgage Capital, Inc. The seller, and then to CSFB Mortgage Securities Corp., depositor. The depositor should have endorsed the Note to US Bank, N.A. The Trustee.
- 8. Whether or not these assignments and endorsements are properly executed as of January 1, 2007, can only be determined upon actual examination of the document; and
- 9. The Deed of Trust shows the original lender assigned the Deed of Trust to the MFRS and the MERS assigned the Deed of Trust to the Trustee, US Bank, N.A;
