**An investment we can't afford to cut**

## Sample letter to legislators

Written in your own words, a personal, thoughtful and well-written letter to your elected officials is powerful and can make a difference. In your letter, educate your elected officials on the impact the governor's budget proposal will have on your schools, students and programs by sharing specific local concerns and examples. Alert them to the types of programs that would be cut if education funding is taken away.

Letters can be written by individuals or on behalf of your entire board. If you are writing on behalf of your board, print your letter on district letterhead; if you are writing an individual letter, use personal stationery if you have it. Letters should be no longer than one page and, if applicable, attach copies of news releases, newspaper articles, adopted board resolutions, etc. to augment your letter.

As a school board member of the **[insert school district/ county office of education]** and concerned voter in your legislative district, I am urging you to reject all legislative proposals that call for massive and devastating cuts to our public schools. In total, the governor is proposing more than a \$4.4 billion reduction in education funding, including a suspension of Proposition 98 in the 2008-09 budget year. Not only are these proposals disastrous to schools in your legislative district and throughout the state, they are fundamentally inconsistent with the state's goal of improving student achievement.

Accordingly, I respectfully urge you to vote "NO" on any budget that fails to honor the state's commitment to public education. I also urge you to consider all options to solve this crisis, including new revenue sources to balance the budget. Thank you for your consideration of this request, and I look forward to being in touch with your office soon.
