COMPLETION OF WORK: All work shall be completed within <u>45 working days</u> following written notice to proceed from the City.

OBTAINING BID DOCUMENTS: Contract documents for the above referenced project may be obtained at the Office of the City Engineer, City Hall, City of Twentynine Palms, upon payment of **\$15.00** for each set, **\$25.00** if mailed. This amount is not refundable.

BID BOND: Each bid response shall be accompanied by the bid securities and attachments as required in Section B – Instructions to Bidders, in an amount not less than ten percent (10%) of the amount named in the bid.

CONTRACTOR'S LICENSE: At the time of the award of the contract, the successful bidder shall possess a valid Class [C57] Water Well Drilling specialty contractor's license.

SUBSTITUTE SECURITIES FOR RETENTION MONEYS: In accordance with Part 5 (Section 22300), Division 2 of the Public Contract Code, a contractor may substitute securities for retention moneys withheld by a public agency to ensure performance under this contract. At the request and expense of the contractor, securities equivalent to the amount withheld shall be deposited with the City of Twentynine Palms, or with a state or federally chartered bank, as the escrow agent, who shall then pay such moneys to the contractor, and upon satisfactory completion of the contract, the securities shall be returned to the Contractor.

REJECTION OF BIDS: The City reserves the right to reject any or all bids or any parts thereof and waive any irregularities or informalities in any bid or in the bidding and to make awards in all or part in the best interest of the City.

WITHDRAWAL OF BID: No bidder may withdraw his bid for a period of sixty (60) days after the date set for the opening bids.

PREVAILING WAGE RATES: Bidders are advised that this project is funded with Community Development Block Grant (CDBG) funds and other public funds. The federal requirements of the Davis-Bacon Act will apply to this project and those requirements will be enforced. The prime contractor and subcontractor are required to pay their laborers and mechanics employed under this contract a wage not less than the minimum wage for the work classifications specified in both the Federal and State wage decisions, when the prime contract amount exceeds \$2,000. The higher of the two wage classifications, State or Federal, Prevailing Wage will be enforced for all work under this contract. The prime contractor is responsible for ensuring subcontractor compliance with Davis-Bacon and Related Act requirements. The Federal Labor Standards Provisions (HUD 4010) apply. A copy of the Federal Prevailing Wage (CA20100037 Modification #11) and HUD 4010 are attached.

ATTACHMENT D: All applicable forms included in "San Bernardino County ECD Attachment D and Special Provisions" (i.e., Labor Standards and Equal Employment contractor and subcontractor forms) must be submitted by the successful bidder prior to the award of the contract.

AARA FORMS: All American Recovery and Reinvestment Act Funding (ARRA) Requirements and Forms must be submitted by the successful bidder prior to the award of the contract, when required.

TRAINEE, HELPER, OR STEP-UP WORK CLASSIFICATIONS: A "Trainee", "Helper", or "Step-up" laborer/mechanic is considered a journeyman in his/her trade for this project, unless the employee is enrolled in an apprenticeship program registered with the Joint Apprenticeship Training Committee (JTAC).

CERTIFIED PAYROLL: A weekly certified payroll is required during the term of construction. Payment of contractor's invoice may be delayed when certified payrolls are not submitted weekly. The District shall make progress payments on any properly completed payment request submitted by the contractor. The payment request shall not be deemed properly completed unless certified payrolls WH-347 have been properly completed and submitted on a weekly basis for each week worked. A copy of the certified payroll is included in the attached, "San Bernardino County ECD Attachment D and Special Provisions".
