N-400: COMPLETED APPLICATION CHECK-OUT LIST

This checklist applies to most naturalization cases. Additional documentation may be required depending on your case. Speak with an authorized immigration law expert to find out about other documents that may be required to file with your application. PROCEDURES, FILING ADDRESSES, FEES, AND FORM EDITIONS CHANGE FREQUENTLY. CHECK WWW.USCIS.GOV FOR UP-TO-DATE INFORMATION BEFORE FILING.

	Two identical color passport-style photographs : Write your name and A-Number lightly on the back of each photo and on the envelope provided.
	Check or Money Order for \$680: Made payable to "U.S. DEPARTMENT OF HOMELAND SECURITY." Write your name and A-Number on the front of the check or money order; Note: Applicants 75 and older may be exempt from paying the \$85 biometric fee and from being fingerprinted. OR

NATURALIZATION: NEXT STEPS

- Receipt Notice: Within two weeks of mailing your application, you should receive a receipt notice from USCIS verifying receipt of your application and payment of fees, or approval of your fee waiver. Keep this receipt as proof USCIS received your application. If you do not receive a notice, call USCIS customer service at: 800-375-5283.
- **Biometrics Appointment**: Shortly after, you will receive a "biometrics" appointment notice to have your fingerprints taken. You MUST go to this appointment with a photo ID and your appointment notice. If you fail to go to this appointment, your Naturalization application will be denied. (Applicants 75 years or older may not be fingerprinted and may not receive this notice.)
- Naturalization Interview: About two to three months after your fingerprints are taken you will be scheduled for your naturalization interview. Be sure to bring all the documents USCIS requests when you receive your naturalization interview appointment notice (originals and copies). At the interview, a USCIS officer will review your N-400 application with you to make sure you meet the qualifications for citizenship, including your ability to understand and speak English (unless you meet certain exemptions). Please see the section "English Language Requirement" on page 4, of the Read Me First Guide for additional information. For test preparation materials, please see the sections "Civil Knowledge and English Vocabulary" on page 75 and "English Reading Vocabulary for the Current Naturalization Test" on page 87 of the Read Me First Guide or visit www.uscis.gov.
- After the Interview: At the end of the interview, the USCIS officer will tell you whether you passed. If you passed, you will be scheduled for the final step, the swearing-in (or oath) ceremony, about one to two months later. If you did not pass, the officer will give you a paper explaining why; you may have to send in more documentation or take the test again. Applicants who fail the English or civics test the first time will be scheduled to re-take the test within 90 days without having to pay another application fee. If you fail the test a second time, your application will be denied.
- Swearing-In Ceremony: At the swearing-in ceremony, you will take the Oath of Allegiance to the United States. You become a U.S. Citizen when you complete the swearing-in ceremony.

Warnings!

- If your mailing address changes while your application is pending you MUST notify USCIS immediately of your address change. Failure to do so will most likely result in the denial of your application. You can change your address with USCIS online at: www.uscis.gov, or by completing and mailing a Change of Address Form, AR-11.
- If you receive a "Request for Evidence" (RFE) from USCIS you should submit whatever additional documentation is required within the time period provided. You should bring as much documentary evidence to your appointment as possible. If your application is denied, you have 30 days to request a hearing by filing Form N-336 along with a \$650 filing fee or a request for a fee waiver. There is no fee for military Naturalization applications under INA 328 & 329.
