Naaiv zeiv sou nza'hmien maengx mbuox jienv meih Buangh gorngv nyei Leiz nyei.

Da'yietv kang - Buangv Gorngv

Se gorngv maiv haih ei oix hiuv duqv haih hnangv haaix nor zoux doqc naaiv kang.

Meih maaiah leiz haih duqv caux dauh zoux bieiv mienh gorngv. Meih heuc mingh branch office wuov dunx daaih buangh.

Se gorngv meih haiz ninh mbuo paaiv daaih maiv horpc, meih maaiah leiz tov daaih gorngv duqv nyei. Maaiah deix heuc douc waac finx mingh gorngv.

Buangh nyei ziangh hoc meih oix zuqc porv mengh nyei mbuox ninh mbuo gorngv weic haaix diuc meih cingx maiv haih ei. Meih lorz yiem hlen mienh tengx gorngv yaac duqv. Meih lorz caengx sic mienh fai dieh dauh tengx yaac duqv nyei. Yie mbuo maiv haih tengx cingv yiem hlen mienh fai caengx sic mienh. Meih mingh lorz gaax buonh deic legal aid office fai bar association haih ziux wuov tengx meih nyei fai. Gorngv taux General Assistance (GA) caux Temporary Assistance for Needy Families (TANF), kungx caengx sic mienh fai zoux gong yiem non-profit legal service nyei mienh haih div duqv meih hnangv.

Se gorngv meih oix buangh, yiem duqv njiec fienx wuov hnoi mingh 45 hnoi ga'nyuoz oix zuqc zoux sou tov (90 hnoi gorngv taux food stamp). Gorngv nyaanh caux zorc baengc daan, meih oix zuqc longc Administrative Hearing Request sou (AFS 443) zoux daaih tov. Yiem buonh deic branch office maaiah mienh haih tengx meih zoux naaiv zeiv sou nyei. Gorngv taux Food Stamps, meih fiev fienx, heuc fai mingh buangh jienv gorngv yaac duqv.

Da'nyeic kang - Duqv Tengx Jienv Mingh

Zuov jienv gorngv nyei ziangh hoc oix duqv nyaanh tengx jienv mingh aeqv doqc naaiv kang.

Meih haih duqv tengx jienv meih nyei nyaanh, foos stamp caux zorc baengc daan hnangv loz mingh taux gorngv sung mingh. Se gorngv meih oix hnangv naaiv, meih oix zuqc tov. Yiem "njiec fienx wuov hnoi (effective date)" tvo fai i "jiez liuz (date of notice)" 10 hnoi meih oix zuqc zoux sou tov. Se gorngv meih oix duqv tengx jienv mingh, meih oix zuqc dimv jienv gorngv "Aeqv" norh yiem naaiv zeiv sou nza'hmien maengx wuov.

Meih oix zuqc longc Administrative Hearing Request sou (AFS 443) zoux daaih tov. Maiv jiex ziangh hoc sou oix zuqc taux AFS wuov. Yiem "njiec fienx" wuov hnoi mingh, fai "jiez liuz" 10 hnoi. Sou oix zuqc taux AFS wuov.

Se gorngv duqv tengx jienv mingh aeqv gorngv gau meih suei, meih duqv liuz wuov deix nyaanh meih oix zuqc jauv nzuonx.

Zuov jienv gorngv nyei ziangh hoc, se gorngv meih dingh jienv maiv longc yietc nyungc aeqv gorngv gau meih hingh, yie mbuo qiexx zuqc mbu'ziex, meih duqv nzengc nzuonx.

Da'faam kang - Buangh Gorngv Siepv

Doqc naaiv kang mangc gaax meih haih tov daaih buangh gorngv siepv nyei fai.

Meih haih tov daaih buangh gorngv siepv se gorngv mei:

- Meih tov maiv duqv tengx jienv mingh.
- Meih tov maiv duqv tengx jiepv sih nyei food stamp fai maiv haih ei gorn zangc paaiv daaih bun food stamp siepv nyei jauv.
- Meih maaiah baengc, OMAP dimv mangc liuz, buatc horpc zuqc tengx siepv, baengc hniev haih hoic maengc nyei mv baac gorn zangc maiv tengx.

Adult and Family Services (AFS) programs tengx nyei jauv maiv horpc zuqc kuei. Tengx nyei jauv, leiz zangc fai fingx tengx nyei jauv maiv horpc kuei haaix dauh. Funx gong-zinh:

- Dongh *maiv duqv* doqc sou nyaanh nyei, longc 1 wuov kang. Longc 1 wuov kang funx *work study* se gorngv maiv duqv tengx, weic baeng baengh funx daaih tengx ERDC caux FS fih hhangv nyei. M'daaih hhangv funx tengx nyei nyaanh nor.
- Dongh *duqv* doqc sou nyaanh wuov deic, longc 2 wuov kang funx ERDC caux 3 wuov kang tengx FS nyei jauv.

Longc 1 wuov kang funx duqv nyei nyaanh (maiv dingc,dingc, hnyangx). Haaix nyungc nyaanh, dimv haaix kang ERDC, Food Stamp, fai yietc zungv.
