There is no cost to publish your family's biography with one photo if it is within the 500 word limit. Biographies over 500 words will be charged 15 cents per word for each word over the limit. Additional photographs are \$5.00 each.

Write the biography in third person (he, she, they) and submit it in typed, double-spaced format on plain paper. If word-processed, please include a labeled disk or CD. Include such information as the date your family came to the county and from what county, state or country your family originated along with immigrant information such as port of entry or name of ship; interesting stories; vocations before and after settling in Guernsey County; dates of marriage, births and

deaths; military service; education; organizations or churches in which your family is involved; or types of businesses owned. Please try and include dates and places if possible. For example read the family histories that are included in this brochure.

This limited edition 8.5" x 11" coffee-table size hardbound history will contain between 200-400 pages, depending on response, printed on glossy, acid-free paper for superior photo reproduction and durability. The *Guernsey County Family History* will include not only family biographies, but also the history of the county and its churches, schools, organizations, and business complemented by hundreds of photographs – truly an heirloom to pass down for generations to come.


Because there will only be a limited number of books printed, it is necessary to collect book orders in advance. All revenue will be held in escrow at a local bank for payment to the publisher at a later date.

Sample Family Biography

CROSSEN

The first Crossen to settle in Guernsey County was John Chestnut (24 July 1841 to 25 Nov. 1921), son of Thomas B. (1812 to about 1900) and Eleanor Stubbs (1822 to 1907) from Belmont County. Thomas and Eleanor had two daughters and eight sons. Three of their sons served in the Civil War. All returned home alive.

Thomas's parents, Nehemiah (abt 1785 to 1865) and Julian. were originally from Pennsylvania. I know of one son and one daughter born to them.

Nehemiah's parents were Samuel Crossen, a private in the Revolutionary War, (1750 to 1810/1820) and Cornelia Sampson (1755 to 1842). They had three sons and five daughters.

John Chestnut served in the Civil War as Capt, B Company, First Ohio Volunteer Calvary. He received two wounds to the right arm, one at Stone River, Tenn. and one at Chickamauga, Ga. His grandsons, Paul and John Clark, loved hearing his stories. In addition, he served as Guernsey County Recorder, was active in the GAR, politics and various community organizations.

John Chestnut married Adeline Cassandra Baldridge (10 Feb. 1842 to 27 May 1928) on 6 April 1867. She was the daughter of Dr. John Baldridge and Mary Hill, daughter of Stephen Hill and Sara Reasoner. Sara was the daughter of Peter

Froman Reasoner and Mary Speers. Stephen was the son of Joseph Hill and Mary Conrad. The Reasoners and the Hills settled in Guernsey County in 1806.

John's father-in-law, Dr. John Baldridge (1797 to 1844), is best known as one of the first doctors in Senecaville and for his involvement in the underground railroad.

John Chestnut and Adeline had five sons and two daughters. Edgar L., Estella (Berry), Augusta A., Ben Paul, John B. Etzell and L. Thomas.

Ben Paul (20 Oct. 1878 to 2 May 1946), my grandfather, married Mary Lloy Boyd (9 April 1879 to 29 Dec. 1945) on 29 May 1907. They had two sons, Paul Etzell (1908 to 1961) and John Clark (18 Dec. 1909 to 6 May 1990). Ben was in business with his father at The Crossen Machine Works in Cambridge. Ben was also a farmer, owner of a sawmill and threshing equipment. Both of his sons joined him in these endeavors.

Paul married Anna Helen Daughtery and had four children. He served in the Air Force in WWII.

John Clark married Evelyn Pauline Vance (14 March 1917 to 27 Aug 1984) on 19 Oct 1937. Evelyn's linage goes back to Robert Vance who settled in Guernsey County in 1817. Clark also worked at the Army Depot during WWII and as a mechanic at the Chevrolet garage. One of his hobbies was writing poetry. Evelyn worked in the white room at RCA making guidance systems for the Minute Man Missiles. Most of her life was happily spent as wife, artist and mother to their only child, Carolyn Jolene (4 April 1941). Jolene, who received a BS in Education from The Ohio State University, married Donald Ray Sigman (4 Oct 1939) on 30 Dee 1961. Don received a PhD in Physics from The Ohio State University. Of this marriage two children were born, Gwendolyn Dawn (11 April 1967) and Steven Ray (14 May 1972). Submitted Jolene Crossen Sigman
