Candidate Questionnaire:

- 1) What are your top three policy issues or concerns?
- 1.Making Ohio's elections free, fair, open and honest so that anyone who is eligible to vote and wants to vote can do so in a system that can be audited and verified.
- 2. Making the ability to do business in Ohio easy and fair to all businesses through streamlined and user-friendly systems, as well as develop innovations to better support the business community. This is key to creating jobs in Ohio.

- 3.Bringing back the jobs that were outsourced by Ohio's current Secretary of State, to prevent individuals outside of the Secretary of State's office from releasing to the public Ohioans' private, personal data, i.e., social security numbers, and placing them at risk of identity theft.
- 2) What is your position in regard to voting reform that requires the presentation of state or federally issued identification in order to participate in elections as a voter?

 I strongly believe that newly enacted Ohio voter identification requirements will disenfranchise voters who are living in poverty, minority, elderly and young or in college. The Secretary of State should be assisting and encouraging Ohioans to vote through helpful and reliable means rather constructing roadblocks to citizens' ability to vote. For years a voter's signature has been the hallmark of identification, because it is extremely difficult to forge a signature. Now, the recent legislative changes in the face of evidence of little or no fraud in voting will result in longer lines, confused and disenfranchised voters and increased difficulties for pollworkers and boards of elections to effectively serve the public.
- 3) How do you intend to address concerns about and problems with election fraud in future state and national elections?
- 4) Do you think the current system of state legislative district apportionment is a fair and open process? If not, what changes do you recommend? I supported State Issue 4 in the November 2005 general election. Since that time, the members of the Ohio House of Representatives have proposed HJR 13 to place on the election ballot a redistricting plan that would eliminate the Apportionment Board and replace it with a seven-member board, the majority of whom are selected by the Ohio Legislature, with the remaining three selected by these legislative appointees. I have publicly stated that I would support this plan if the following changes were made to it. To date the joint resolution does not meet with my support.
- 1. Competitiveness of districts must be a priority and measured objectively through a verifiable formula. The language of HJR 13 calls for "best efforts to maximize competitiveness" is inadequate.
- 2. Language should be included mandating that the proposal complies with the Voting Rights Act to ensure fair representation of minority voters and to ensure one-person, one-vote is honored and kept sacred.
- 3. Language should be added requiring that in case of deadlock, the most competitive plan before the Board should be automatically approved (currently there is no procedure to deal with deadlock).
- 4. Appeals involving issues pertaining to the U.S. Constitution, the Voting Rights Act and any federal redistricting law must be made to federal courts, and cannot be brought before the Ohio Supreme Courts. Any challenges of the plan that would be created to review the plan. This panel would consist of 2 judges of each political party, for example, appointed by the senior appellate judge of each political party, and whose collective decision on a plan would have to be reached by at least 3 judges of the panel.
- 5. The drawing of district lines should be left to the Apportionment Board where the majority of members are elected by the people. Give the Apportionment Board rules for drawing fair district lines. That's what really matters. HJR 13 throws the baby out with the bath water and puts in the hands of the legislature the appointment of a majority of those who would draw their own district lines. There is a loss of the checks and balances of government.
