Prescribed Registration Application Form :

Three copies of latest passport size photographs mentioning the name back side of it.

Demand Draft of Rs. 30,900/- (Rs. Thirty thousand Nine Hundred Only) in favour of Registrar **Maharashtra Medical Council** payable at **Mumbai**. upto 31st Jan., 2015 and from Feb. 2015 plus Rs.100/- Per month as late fee. (Rupees 2000/- is as a registration fee and Rs. 28,900/- as a late fees from January 1991 till Jan. 2015 : Late fees of Rs.100/- per month.) For example as under :

- Reasons why he/she has not renewed registration on previous renewal programme in 1988-89.
- I have not been found guilty in any court.
- There is no civil /criminal case/writ petition against me in any court till date against me.
- I have not done any unethical /mis-conduct .
- I shall be held responsible if it is proved that I have done any unethical/ unlawful deed in past during non register period and Maharashtra Medical Council will not be made party to my past unethical/unlawful deed, and Maharashtra Medical Council will be at liberty to Act according to Rules & Act of Maharashtra Medical Council regarding Registration.

Please submit Indemnity Bond. Indemnity Bond should be filled as per format given below by the Council. (with notarized)
