SUBJECT: 2014-15 State and Representative Team Management and Selection

The 2014-15 State and Representative Team Management Group was endorsed by the Surf Sports Standing Committee at the September meeting. The Group is:

- Jason Matte Head Coach and Selector
- Shaun Burnett selector / coach
- Vacant selector / coach
- Ingrid Cobiac Team Manager

The Group is working through what further support may be required and has initially decided that a designated <u>Junior Development Coach</u> and a <u>High Performance Beach Coordinator</u> are required. A third selector / coach is also being sought. Please see <u>expression of interest form below</u>. The key dates are:

- Southern States Development Camp and Challenge January 8th to 11th 2014 (Victoria)
- Interstate Championships January 23rd (Sydney)

The 2014-15 Program will take a slightly different format to the past couple of seasons.

State Team and Development Team Selection - Along with last year's results and past performances a number of events that the selectors will consider have been identified (see below). This will provide the opportunity for selectors to observe any athlete that wishes to be considered across a range of events. The relevant events will be promoted and further events, such as trials, may be added to the calendar as required. Following these selection events a State Team and a Development Team will be selected to compete at the Interstate Championships and Southern States Development Challenge respectively.

Team composition: The **State Team** composition has changed significantly this year and will consist of a senior team (6 male and 6 female open competitors) and a youth team (4 male and 4 female U19 competitors and 2 male and 2 female U17). This composition reflects the national team composition. The **Development Team** will consist of 4 male and 4 female from each of U13, U14 and U15.

This year the State and Representative Team Management Group are calling for expressions of interest from athletes wishing to be selected in the **STATE TEAM**. Please see form below. The State and Representative Team Management Group aim **to observe all eligible athletes for the Development Team** so an expression of interest is **NOT** required.
