GO BEYOND

Directions to Tappan Hill Mansion, Tarrytown, NY

For GPS: Use this address: 200 Gunpowder Lane, Tarrytown, NY

From upstate New York and New Jersey:

From the Tappan Zee Bridge: After toll booth take first exit (exit 9). At end of ramp turn right onto Broadway (Route 9 North). Continue ½ mile and turn right onto Prospect Avenue. Drive .6 miles. Cross Benedict Avenue and continue straight onto Highland Avenue. Go .1 mile and turn left onto Gunpowder Lane.

From New York City:

North on I-87 to second exit 9 (Rte. 119 – Tarrytown). At end of ramp, turn left onto Route 119W / White Plains Road. Continue to end. Turn right onto Broadway (Route 9 North). Continue ½ mile and turn right onto Prospect Avenue. Drive .6 miles. Cross Benedict Avenue and continue straight onto Highland Avenue. Go .1 mile and turn left onto Gunpowder Lane.

From Connecticut:

I-95 South to I-287 West. Take exit 1 – Tarrytown. At end of ramp, turn right onto New York 119 W / White Plains Rd. Go .3 miles. Take a slight right onto Benedict Avenue. Go 1 mile. Turn right onto Highland Avenue. In .1 miles, turn left onto Gunpowder Lane.

From New York (East of the Hudson):

I-684 South. Take exit 5 and merge onto the Saw Mill Parkway S. Continue 17.5 miles. Take exit 22 toward I-87 W/I-287 W/Albany/New York City. Keep right at the fork, following signs for NY-119/Tarrytown. Turn right onto New York 119 W / White Plains Rd. Go .3 miles. Take a slight right onto Benedict Ave. Go 1 mile. Turn right onto Highland Avenue. In .1 miles, turn left onto Gunpowder Lane.
