Dora Bronston	Ms. D. Bronston commented that she recently attended the Tax Incentive Review Committee workshop and that it was very informative; Denise Hamet and Matt Eisenbraun did a great job. She also attended the back to school event at Douglass Park put on by the Community Building Institute and also attended the Marshall High School kick-off event. She commented that there is great concern for our community's young people and that these events demonstrated that there are a lot of adults supporting our youth. She attended the Arts Central Foundation auction and remarked that it was well attended. She commented that she attended the ribbon cutting event for the new Wound Care Center and Hyperbaric Services at the Atrium and attended the unveiling of the new Central Connections (formerly Middletown Senior Center). She encouraged everyone to come out to the last movie of the summer and announced that the ZAP band would be performing on August 22. She reminded everyone that the Butler County Board of Elections still needs poll workers for the November election.		
Anita Scott Jones	Ms. A. Scott Jones continued her "Did You Know?" commentary and shared a news article about the 1913 flood that ravaged Middletown. "Thousands of families in the Great Miami River Valley felt the empathy in that Hamilton, Cincinnati, Dayton, as well as Middletown, even had some flood levies, suffered lost lives and massive property losses. Homes, particularly in the downtown area of Broad, Vanderveer and Main Street, east to Curtis Street, and in the Lakeside area northeast of downtown, the water levels were chest high on the first floor of many homes and offices. The then new Middletown Public Library was flooded up to the first floor. More than one thousand families had to move to dry ground. When it was over, it became known as the 'Worst Flood of Modern Times' and resulted in the creation of the Miami Conservancy District, the first of its kind in the nation and a model for many other areas."		
Joseph Mulligan	Mr. J. Mulligan commented, "Today, I announce that I will not seek reelection to Middletown City Council. After careful thought, I have decided to seek the position of State Representative for the 53 <sup>rd</sup> District of the Ohio. The primary election for that seat will take place in March of next year. I'm excited		

	about the opportunity to serve the citizens of the 53 <sup>rd</sup> District, which includes northern and western parts of Butler County. My background in business, public service, and law will be assets in the decision making process in the legislature. It's vital that we elect leaders to the General Assembly that understand the importance of keeping government effective, accountable and limited. Our area is fortunate to have had robust growth in recent years, while maintaining our heritage. Strong leadership with sound policies will help this District and State retain current residents and businesses, while attracting new residents and new employers. Seeking higher office was a difficult decision for me because in the last four years, I have been part of a team that has led Middletown's comeback, and we are only in the early innings of our comeback. We are in the midst of hundreds of millions of dollars in new commercial investment. WE are revitalizing neighborhoods. We have worked to restore the balance to our local economy by responsibly addressing the complex issue of subsidized housing. We have worked to reduce subsidized housing to an amount that is appropriate for a community our size. We have made the difficult decision to reduce our City's workforce to strengthen the City's finances and end years of deficit spending. Res. No. R2015-29 Advance to Employee Benefits Fund	<b>Resolution No. R2015-29,</b> a resolution authorizing a transfer from the General Fund to the Employee Benefits Fund, as an advance subject to reimbursement, and declaring an emergency was read.
	<ul> <li>Mr. Adkins explained that over the last several years the City's costs for healthcare have remained very stable. For the period of 2011 through 2014 overall costs have increased by less than 1%. The healthcare committee has worked very hard to make changes that have kept costs well below the inflation rate. However, as we are self-insured, healthcare inflation still exists and the City can experience volatility. The first half of 2015 has seen some significant increases in cost; additional appropriations are required and may potentially be used to fund the program. The reasons for the increase are as follows: <ul> <li>Anthem changed its weekly pay dates in March (billing occurred on Wednesday and now occurs on Monday). This resulted in an extra "five pay month" in 2015 (typically there are four, "five pay months," but in 2015, there will be five [March, April, July, October and December]</li> <li>Overall costs through July have increased by 24.8% because three large claimants have impacted the cost structure in the first six months. Last year, one had occurred in the same period. Another six large claimants have entered the watch list. Some of these are not reoccurring in nature, but others are chronic and ongoing. This is a large spike in recent claims, based on over a decade of history; it is not expected to continue long term.</li> <li>Pharmacy costs are increasing, primarily in the area of specialty Rx. In particular, cancer and arthritis medications have increased. We also expect higher costs from the new Hepatitis C vaccine.</li> </ul> </li> <li>The committee is aware of the issue and is actively working towards solutions that will reduce expenses in 2016. If the appropriations from the healthcare reserve are used in 2015, they will be added back in</li> </ul>

the formula for rates and budget in 2016. This will allow the City to account for and recoup the funding so that the fund remains solvent. The committee is reviewing several cost control mechanisms that include:
<ul> <li>Benefit changes and carrier changes through the RFP process</li> <li>Review of fully insured options that would limit volatility</li> </ul>
<ul> <li>Spousal strategies for those who have other coverage</li> <li>Contribution increases</li> </ul>
These changes will be finalized in September and incorporated into the 2016 budget. The funds to be advanced from the General Fund will be repaid in 2016. The requested funds are worst case; if claims level out, the entire amount may not be needed.

Ms. A. Scott Jones moved to approve Resolution No. R2015-30, a resolution to make adjustments to appropriations for current expenses and other expenditures of the City of Middletown, Counties of Butler and Warren, State of Ohio, for the period ending December 31, 2015, and declaring an emergency (Employee Benefits Fund). At 6:00 p.m. the meeting continued with a work session held in Conference Room 2C.
Finance Director Greis explained many of the upcoming changes to the municipal income tax collection and reporting and the impact it will have on the City.
Mr. Adkins provided detailed property descriptions to Council Members and explained that the City and the Middletown City School District are discussing swapping several parcels of land, including the lighted baseball/softball fields at Lefferson Park. Other parcels being discussed include: Barnitz Park, the former Roosevelt Elementary School site and a small strip of land adjacent to the former Verity Middle School. Mr. Adkins said that the school approached the City about the land swap, which is in the preliminary/conceptual stage, because new playing fields were going to be needed for the Middies baseball and softball teams. The current fields on the Middletown High School campus on North Breiel Boulevard will be taken out to make way for construction of the district's new middle school. Mr. Adkins said the land swap wouldn't result in any savings for either entity. The Lefferson park baseball/softball fields are currently being used by the Butler County Bombers, and their officials will be included in the discussions about the land swap. The pickleball, tennis and basketball courts at Lefferson Park would not be a part of the City's land trade with the schools. The schools would receive a parking access easement at the park where the City has a maintenance area and a salt dome. In exchange for the ballfield complex, the City would receive a small piece of land next to the former Verity Middle School, which is now owned by Berachah Church, Adkins said. In other components of the deal, the City would give the school district the 7.7-acre Barnitz Park near to the Middies football stadium in exchange for the former Roosevelt Elementary School property on Central Avenue. The school building that used to sit there has been razed but the district still owns the open green space of about 6.79 acres.
City Manager Doug Adkins presented preliminary cost estimates of \$162 million to reconstruct, repair and improve Middletown's streets. To accomplish this, the City would have to spend about \$8.1 mil- lion a year, or roughly four times what it spends on average, to get the job done. He said in the first five years of a proposed 20-year plan, the City would spend nearly \$860,000 just in preventative maintenance to keep the 114 lane miles or 18 percent of streets in satisfactory condition. The costs to repair streets range from \$1.07 per square yard for crack sealing and minor patching to \$33.31 per square yard to fully reconstruct a street with 6.5 inches of asphalt that would also include handicap ramps and spot curb repairs. Middletown spends an average of about \$2.2 million a year for street and road improvements outside of state and federal grants. In 2014, the City spent about \$4.2 million, including state and federal grants. Mr. Adkins shared information with council members about how the City could raise additional revenues to fix its streets. Suggestions included moving the costs of street lighting from the City to property owners as other area communities have done, which would raise about \$800,000 a year; placing a 0.25 percent income tax increase that would be dedicated to

	streets and would generate about \$3 million a year; or a property tax increase that would be dedi- cated for street repairs or improvements (one mill of City property tax generates an estimated \$620,000 annually.
TV Middletown	Mr. Adkins reported that TV Middletown officials had asked the City to give them \$20,000 to help make ends meet for the rest of the year. He explained that the public access channel on Time Warner Cable is going off the air and moving to an online-only format, primarily due to financial challenges and mounting bills. Recently, TVM's two full-time employees and one part-time employee were laid off. The City had previously offered the station \$20,000 in exchange for providing programming that the City wanted done. Mr. Adkins expressed his concern that they can't do the programming being asked, and that the \$20,000 is taxpayer money. He said that TV Middletown officials provided him a preliminary profit-and-loss overview for 2016. TVM has put their building on the market, and submitted an appeal to the Butler County Board of Revision to get relief from increased property taxes on the building. The station runs on a base budget of \$150,000 in which \$112,000 is provided by the City which is a part of the cable franchise fee that is paid by Time Warner, and \$38,000 is provided by the Middletown City Schools. The nonprofit also relies on fund-raisers and had a telethon last spring. City Council members told Adkins they wanted him to continue discussions with TVM, which provides good community programming, and also explore options such as streaming council meetings directly to the City's website. Adkins said the City is looking into possibly updating its equipment in council chambers where council and school board meetings are recorded and later cablecast.

	Mr. Adkins explained that Middletown's water and sewer rates consistently rank in the lower half of communities in the annual Oakwood Water and Sewer Rate Survey for southwest Ohio. We are currently 25th out of 63 communities surveyed for lowest sewer rates. A significant factor affecting future sewer rate increases are the need for major capital improvements to the system. Middletown, like many other older cities across the nation, has combined sewers that drain both rain water and sanitary sewage. The combined sewer flow is transported to the wastewater treatment plant during dry periods. When there are significant rain events the combined sewers are overloaded with rain water and discharge at several points along the river. The City is in active discussions with the EPA on a solution to address combined sewer overflows. Multiple alternatives are being evaluated to reduce the number of overflows. The alternatives range in cost from approximately \$80 to \$250 million over a 25 year period. During this same time-frame, major rehabilitation will be necessary for our sewer collection system and wastewater treatment plant. As you may recall there have been multiple sewer system is 50 years old or older and will require extensive rehabilitation going forward. \$142 million is needed to repair the sewer system over the next 25 years. An additional \$68 million will be needed for improvements at the wastewater treatment plant as well. Most the major components of the plant were installed in the mid 1950's. All told, the City is looking at \$290 to \$460 million in future improvements to the system. Funding options for these improvements are limited mostly to user fees; therefore, it is necessary to adjust sewer rates accordingly. This fee will cost a typical residential user an additional \$2.11 per month for sewer. The infrastructure fee will be a separate line item on individual utility bills. The 10% infrastructure fee will generate approximately \$850,000 per year.

#### PRESENTATION

Judith Feinberg, M.D. – Cincinnati Exchange Project

Several questions arose from the presentation.

Dr. Patrick questioned the public perception of such a program and would this program bring addicts in from other areas? People do sometimes come from other areas – usually not too far off. Dr. Feinberg stated if the board chose to they could limit the exchange to Middletown residents only but preference would be to leave open for everyone. There are 200 exchanges around the U.S. Five studies have been conducted each showing a decrease in drug use and infections (hepatitis C/HIV).

Dr. Feinberg conservatively estimates there are at least 10,000 addicts in the area. It could easily be two to three times that many.

Has Cleveland seen a decrease? There has been a huge impact on HIV in the area. It is hard to say if deaths have been reduced, but they have seen a decline in everything else related to heroin addiction. Death rate in Hamilton/Butler counties have gone up every year.

Treatment – how many people relapse? Very few people are in permanent recovery after their first attempts for treatment. Some has been in treatment three, four or more times. Only five percent of people who attend programs will succeed. Methadone is one drug used for treatment and it is pretty much a lifelong drug. Almost 35% of addicts have a prescription for mental health. Treatment should be individualized.

Are there any liabilities to the Board of Health? Cleveland has never had a problem. Dr. Feinberg could not comment that there will never be a problem, but historically there has not been.

#### Discussion

The City Manager expressed concern and the need for programs to address the increase of HIV, Hepatitis C and other aspects of addiction. There is also a need to educate the public.



#### Application for Designated Outdoor Refreshment Area

The purpose of this application is to request that City Council create a Designated Outdoor Refreshment Area (DORA) in the City of Middletown. The application includes the following sections:

- 1. A map of the proposed designated outdoor refreshment area (one-half square mile or less)
- 2. A statement of the nature and type of establishments in the proposed area
- A statement verifying that not less than four liquor permit holders are included in the area
- 4. Evidence that the land use in the DORA is in accord with the Master Plan
- 5. Proposed requirements that ensure the public health and safety in the DORA
- 6. Dates and Hours of Operation

#### Section 1

See attached map, and list of addresses in the proposed area (Exhibits "A" and "B" respectively).

#### Section 2

The proposed DORA contains primarily businesses in the form of art shops, restaurants, financial establishments, boutiques and five liquor permit holders.

#### Section 3

There are currently five liquor permit holders in the proposed DORA (Forest Hills Country Club, Canal House, Murphy's Landing, @ The Square and the American Legion). A sixth business, Central Tap and Pint, has made application for a permit as well.

#### Section 4

When the Master Plan was created, the state law permitting outdoor refreshment areas did not exist. The Master Plan, however, speaks to increased businesses, tourism and economic development. A DORA helps the City of Middletown to progress in each of these areas, and language to that effect will be included in future changes to the Master Plan.

Further, the proposed area for the DORA is primarily in an Entertainment District, established previously by City Council. The Entertainment District was created in part to allow a greater number of liquor permit establishments in a particular area. The DORA is a one method of enhancing the Entertainment District.





## Safety Plan

## Designated Outdoor Refreshment Area (DORA)

In the event the City should create a Designated Outdoor Refreshment Area (DORA), the Division of Police will be responsible for the public safety in the area. This will be accomplished in the following manner.

- A. The Division of Police staffs patrol officers using a beat system. The proposed DORA is centrally located, and comprises the majority of, beat 9.
- B. When the DORA is in operation, typically from 6pm to midnight on Thursday, Friday and Saturday night and other times as determined by the Chief of Police, the on-duty supervisor will ensure beat 9 is staffed by at least one officer.
- C. In the event a larger than normal number of people are in the DORA, the on-duty supervisor is authorized to assign two or more officers to beat 9.
- D. In the event of a City sponsored special event in the DORA that is likely to draw a larger than normal number of people, the Chief of Police may require additional officers to be assigned solely to the DORA.
- E. In the event of a private special event in the DORA that is likely to draw a larger than normal number of people to the DORA, the Chief of Police may require the event organizer to hire additional police personnel to be assigned to the area.
- F. At any point when the on-duty supervisor or the Chief of Police deems it necessary, officer may be assigned to the DORA with the sole responsibility of providing police service to the area.

Three traffic signals will be modified to meet current standards. Waterline will be replaced and upsized to meet future demands. Partial funding has been secured through the Ohio-Kentucky-Indiana Regional Council of Governments (OKI). Construction is scheduled to begin in 2017.

## EXHIBIT "A"

(a) There is hereby established a Pioneer Cemetery Board, which shall be composed of no more than five (5) members, who shall be appointed by City Council.

(b) One (1) of the members of the Board shall be appointed for a term of one (1) year, beginning January 1, 2011. Two (2) of the members of the Board shall be appointed for a term of two (2) years, beginning January 1, 2011. The remaining two (2) members of the Board shall be appointed for a term of three (3) years, beginning January 1, 2011. At the expiration of their initial terms, Board members shall be appointed for three (3) year terms, which shall begin on January 1. However, if a vacancy occurs on the Board, the term of the member appointed to fill the vacant seat shall begin on the date of appointment and terminate at the end of the term of the member originally appointed to that seat.

(c) Notwithstanding Section 260.03 of the Middletown Codified Ordinances, City Council may appoint persons who are neither an elector of the City nor a resident of the City to the Cemetery Board if City Council determines, in its sole discretion, that such appointment is beneficial to the Cemetery Board. Appointment by City Council creates an irrebuttable presumption that City Council has made this determination that the appointment is beneficial to the Cemetery Board. At all times at least three (3) members of the Cemetery Board shall be electors and/or residents of the City. DATE: August 24, 2015

## ORDINANCE NO. 02015-47

AN ORDINANCE AMENDING THE SEWER RATES LEVIED AND ASSESSED IN SECTION 1040.03 OF THE CODIFIED ORDINANCES BY ADDING A SURCHARGE TO BE APPLIED TO INFRASTRUCTURE IMPROVEMENTS TO THE CITY SANITARY SEWERAGE SYSTEM, INCLUDING THE PUMPING, TREATMENT AND DISPOSAL WORKS.

**WHEREAS**, Section 1040.02 of the Middletown Codified Ordinances (MCO) declares it necessary and conducive to the protection of the public health, safety, welfare and convenience of the City to levy and collect charges and/or rentals upon real property connected to the City sewerage system; and

WHEREAS, Section 1040.03 of the MCO levies and assesses sewer rates to implement that need; and

**WHEREAS**, the public infrastructure of the City's sewerage system continues to age, requiring maintenance, repair and replacement; and

WHEREAS, on-going upgrades and improvements are necessary and will continue to be necessary to maintain a sewerage system which is ecologically friendly and meets the needs of our environment; and

**WHEREAS**, the present sewer rate structure is not able to support the present and forthcoming capital needs of the City sewerage system;

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of the City of Middletown, Butler/Warren Counties, Ohio that:

## Section 1

Effective October 15, 2015, there is hereby levied and assessed upon each lot, parcel of land, building or premises having any sewer connection with the sanitary sewerage system of the City or otherwise discharging sewage, industrial wastes, water or other liquids, either directly or indirectly, into the City sanitary sewerage system, or to any other person or entity paying service charges or rental payments (hereinafter collectively referred to as "base sewer rates") to the City in compliance with MCO §1040.03, a surcharge equal to ten percent (10%) of the base sewer rates, which shall be known as the "sewer infrastructure surcharge". Base sewer rates shall not include any surcharge amount assessed and applied in accordance with MCO §1040.03(f).

## Section 2

The sewer infrastructure surcharge shall be in addition to all other sewer rates imposed by MCO §1040.03, and shall be payable in the same manner, at the same time and in accordance with the same conditions as the base sewer rates (set forth in MCO Section 1040.04). Any reference to "sewer rates" or "total sewer rates" in this Ordinance shall include both the base sewer rates and the sewer infrastructure surcharge.

## Section 3

Notwithstanding the requirements of MCO §1040.07, the monies collected as the sewer infrastructure surcharge shall be maintained in a separate account from the Sanitary Sewer Fund and shall be applied to capital expenses for infrastructure improvements to the City sewerage system. Nothing in this Section 2 is intended to limit expenditures for capital expenditures or infrastructure improvements to the City sewerage system from any other fund, account or source of revenue which is otherwise legally permissible.

## Section 4

City Council determines that the sewer infrastructure surcharge is necessary to address the present infrastructure needs of the City sewerage system and prepare the system for future upgrades to meet the applicable environmental standards.

## Section 5

This ordinance shall take effect and be in force from and after the earliest period allowed by law.

## SEWER USER RATE INCREASE – INFRASTRUCTURE FEE

## **PURPOSE**

To adopt legislation approving a 10% user rate increase in the sewer fund to be used solely for sewer infrastructure improvements.

## **BACKGROUND and FINDINGS**

Sewer rates are typically reviewed with City Council every couple of years taking in consideration operational, maintenance, and capital improvement needs of the sewer system. The rates were last discussed in 2013 with a rate increase of 10% effective January 1<sup>st</sup> of 2014.

Middletown's water and sewer rates consistently rank in the lower half of communities in the annual Oakwood Water and Sewer Rate Survey for southwest Ohio. We are currently 25<sup>th</sup> out of 63 communities surveyed for lowest sewer rates.

A significant factor affecting future sewer rate increases are the need for major capital improvements to the system. Middletown, like many other older cities across the nation, has combined sewers that drain both rain water and sanitary sewage. The combined sewer flow is transported to the wastewater treatment plant during dry periods. When there are significant rain events the combined sewers are overloaded with rain water and discharge at several points along the river. The City is in active discussions with the EPA on a solution to address combined sewer overflows. Multiple alternatives are being evaluated to reduce the number of overflows. The alternatives range is cost from approximately \$80 to \$250 million over a 25 year period. During this same time frame major rehabilitation will be necessary for our sewer collection system and wastewater treatment plant. As you may recall there have been multiple sewer collapses over the past several years. This is just the tip of the iceberg. Nearly half of the City's sewer system is 50 years old or older and will require extensive rehabilitation going forward. \$142 million is needed to repair the sewer system over the next 25 years. An additional \$68 million will be needed for improvements at the wastewater treatment plant as well. Most the major components of the plant were installed in the mid-50's

All told the City is looking at \$290 to \$460 million in future improvements to the system. Funding options for these improvements are limited mostly to user fees therefore it is necessary to adjust sewer rates accordingly.

## **ALTERNATIVES**

Do not create the infrastructure fee.

## FINANCIAL IMPACT

This fee will cost a typical residential user an additional \$2.11 per month for sewer. The infrastructure fee will be a separate line item on individual utility bills. The 10% infrastructure fee will generate approximately \$850,000 per year.



**WHEREAS**, the City has purchased natural gas from Constellation NewEnergy Gas (fka Proliance Gas) for many years; and

This Council hereby determines that the procedure to be followed in the award and execution of the aforesaid contract shall consist solely of the procedure set forth in this Ordinance and the provisions of Chapter 735, Ohio Revised Code, shall not be applicable to the award and execution of the aforesaid contract.

Section	4

It is hereby determined that the subject matter of this legislation is not of a general and permanent nature, does not provide for a public improvement, and does not assess a tax or payment.

## **Purchase of Natural Gas**

## **PURPOSE**

To request authorization to enter into a contract for natural gas with Constellation NewEnergy Gas, of Chicago, IL, in an amount not to exceed \$90,000.

## **BACKGROUND and FINDINGS**

Various City Departments use natural gas in their facilities. The City typically uses a total of approximately 15,000 Dth/year spread over all the facilities. We have worked successfully with Constellation (formerly Proliance Gas) for many years, generally signing two year contracts at a time. The current contract has expired, and the contract has been extended at the "floating" NYMEX rate for the past several months.

We are requesting a new two-year contract be established. This plan will diversify our acquisition process by splitting our gas between three different purchasing options. The NYMEX costs will be divided into three distinct categories to protect against upside price risk (lock-in, "float," and a managed program). The contract manager is local, has worked with us for many years and is trustworthy, and the company has prepared a plan for us that could potentially save us money over the current plan. For these reasons, it is requested the bid procedure be waived, and this be treated similar to a professional service contract.

### FINANCIAL IMPACT

The contract requested will begin October 1, 2015, and will continue until September 30, 2017. Adequate funding for natural gas is (and will be in the future) included in each of the budget years.

## **EMERGENCY/NON EMERGENCY**

Emergency legislation is requested so the contract can be established by October 1, 2015. It would benefit the City to begin the savings immediately, rather than "float" at a higher price for another two months should emergency legislation not be passed.

## RAILROAD / SIGNAL PREEMPTION PROJECT

## **PURPOSE**

Authorize the City Manager to enter into a contract with Capital Electric Line Builders to proceed with the Railroad / Signal Preemption project.

## **BACKGROUND AND FINDINGS**

The City is proposing to proceed with the Railroad / Signal Preemption project which consists of upgrading four signalized intersections along North University Blvd to meet railroad preemption requirements. The upgrade includes installation of new controllers, new signal phasing & timing, LED blank-out signs and interconnect with railroad equipment. In addition, this project will purchase a centralized control system and convert 19 additional intersections to the centralized control system.

Three contractors submitted a bid for the project. Capital Electric Line Builders was the lowest and best bid.

## ALTERNATIVES

Only upgrade the intersections in the base bid as required by the agreement with the Ohio Rail Development Commission.

## FINANCIAL IMPACTS

The lowest bid received for this project on August 28, 2015 was \$452,636.56 which is 6% higher than the engineer's estimate and less than 1% lower than the next bidder. To best utilize the funds budgeted for the project and based on the alternate unit prices stated in the bids, staff recommends upgrading 15 additional signals, making the total contract amount \$551,715.31.

The project will be funded by the General Capital Fund (220) (\$288,215.31) and federal funds distributed by the Ohio Rail Development Commission (ORDC) (\$263,500). The General Capital Funds are included in the 2015 Capital Improvement budget. A supplemental appropriation for the ORDC funds in the amount of \$263,500 will also be required.

## **EMERGENCY/NON EMERGENCY**

A second reading emergency is requested in order to begin the project as soon as possible.
