## 1 Mile Kids Run/ Walk

Date/Time:	Saturday May 4th. 5K starts at 7:30am. 1 Mile Kids Run will start after the completion of the 5K.
<b></b> -	1 Mile participants please arrive by 7:15am to avoid interfering with the start of the 5K race.
Location:	Renaud Spirit Center, 2650 Tri Sports Circle, O'Fallon, MO 63368
Packet:	Packet pick-up will be from 9:00am to 9:00pm on Friday May 3 <sup>rd</sup> at the Renaud Spirit Center. A map of the course will be included in your packet. You may also view it online at our website www.renaudspiritcenter.com.
Course:	The 5K and 1 mile Kids Run/Walk will be held outside the Renaud Spirit Center through the city's beautiful Sports Park and will go thru the Dardenne Prairie subdivision.
Registration:	5K Run/Walk individual entry fee is \$21 for 15 years of age and up and \$16 for kids 14 and under. 1 mile Kids Run individual entry fee is \$16 for 15 years of age and up and \$13 for kids 14 and under. A \$5 late fee will be charged from April 13 <sup>th</sup> -May 3rd. A \$10 late fee will be charged for race day registration. Registration is limited to 300 competitors.
Awards:	Male and Female awards for the 5K will be given to the top 3 finishers overall and to the top 3 finishers in 7 age groups: 14 & under, 15-19, 20-29, 30-39, 40-49, 50-59 and 60+. 1 mile participants will receive finisher ribbons.
