#### Preparing and Submitting Your CV

1 Seek clarification from your AP(E)L co-ordinator at an early stage if you are uncertain about any aspect of preparing your CV.

2 You will need to prepare two copies of your CV one to submit, which will not be returned, and one to retain as your master copy.

3 Please ensure that your CV is firmly secured in a slim plastic folder with a transparent cover. This is to enable easy identification and to ensure it remains intact throughout internal posting and handling. Please do not put the pages in individual plastic wallets as this makes them difficult to read.

4 A cover page should be included with your CV. This should clearly indicate your name, contact details and your signature. Remember to date the cover page.

5 Your CV should be typed or word-processed, single-sided, on white or buff A4 paper. We are not able to accept e-mailed copies. It is recommended that you use Arial, font size 12, left justified and without underlining. Avoid elaborate font styles and inappropriate artwork.

6 In constructing your CV and presenting your evidence you might find it helpful to study the aims and learning outcomes of the following modules – Care Delivery, Care Management and Professional and Ethical Issues. The learning outcomes for these Diploma Level modules are mapped against the evidence presented in your CV to award your credits. These learning outcomes can be located via www.plymouth.ac.uk/courses and click on Continuing Education – Health.

7 Your CV will be scrutinised and our aim is that you should normally have received feedback on the outcomes within six weeks.

# **Preparing Your CV**





As part of The University of Plymouth's strategy of widening access, we are now offering the opportunity for experienced healthcare professionals\* to have their experience recognised in the form of 100 Level 2 academic credits. This, together with the completion of the module 'Evidence Based Practice (HEA273)' and a recognised study skills course will enable students to access degree level study. Part of process of accessing this opportunity requires the preparation of a comprehensive CV, demonstrating that you have constructively used your professional experience to promote your learning. The evidence that you provide in your CV will be mapped against the required University learning outcomes to ensure that you have demonstrated your achievement of the necessary competencies.

#### A Career Summary

This is a simple statement that captures your career to date. It should highlight your experience and skills, your knowledge base and attributes.

#### example:

A paramedic supervisor who is a proven team leader and people motivator. Confident and competent in practice due to 15 years of expertise in an ever changing acute and classroom environment.

### \* Healthcare professionals who have five years, full time, or equivalent experience, in practice.

#### Professional Qualifications

#### example:

 Registered Nurse, Paramedic Supervisor, Physiotherapist, Occupational Therapist, Social Worker, Midwife, Podiatrist, Operating Department Practitioner, Health Visitor.

#### Employment Details

- who you worked for, when and in what role
- what you actually did

#### example:

Royal Devon & Exeter Hospital 1999 – 2002

- F grade staff nurse in coronary care
- Delivered total patient care to a group of acutely ill coronary patients
- Contributed to the operational management of the unit, staff and resources and delegated management of the unit in the absence of the ward manager
- Developed a range of information leaflets for patients
- Improved...
