RESOLUTION OF THE MAYOR AND TOWNSHIP COMMITTEE OF THE TOWNSHIP OF HARRISON, IN THE COUNTY OF GLOUCESTER AND STATE OF NEW JERSEY AUTHORIZING A FIREWORKS DISPLAY AT THE ELLA HARRIS PARK ON THE EVENING OF MAY 04, 2013, RAIN DATE MAY 05, 2013

WHEREAS, formal application has been made to the governing body of the Township of Harrison by the Harrison Township Recreation Commission for a permit to hold a public display of fireworks at the Ella Harris Park on the evening of Saturday, May 04, 2013, rain date Sunday, May 05, 2013; and

WHEREAS, said application indicates that such display will be supervised by competent and experienced persons in compliance with *N.J.S.A.* 21:3-4 of the State of New Jersey, and will not be a detriment to the community, but to the contrary will offer substitute for the heretofore indiscriminate and unlawful use of fireworks on the part of the individuals.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Harrison, as follows:

1. That pursuant to the authority granted under N.J.S.A. 21:3-1 and 21:3-4 of the State of New Jersey, the Municipal Clerk of the Township of Harrison be and she is hereby authorized to make, execute and deliver a good and sufficient license of permit to the Harrison Township Recreation Commission, authorizing said association to conduct a public display of fireworks at the Ella Harris Park during the evening of Saturday, May 04, 2013 or rain date Sunday, May 05, 2013 under the supervision of Schaefer Pyrotechnics, Inc, 376 Hartman Bridge Road, Ronks, Pennsylvania 17572, a fully qualified pyrotechnical firm the company named in the applicant heretofore submitted to the Municipal Clerk. Said fireworks are to be delivered on May 04, 2013 and will remain on the truck at Ella Harris Park until fired. Said license shall be without force and effect until such time as the application therefore shall file with the Municipal Clerk insurance coverage satisfactory to the Trico Jif Insurance Fund which would indemnify any person who may receive or sustain injury to this person or property by reason of any discharge of the fireworks in question. All operations incidental to such display shall be subject to the approval of the Chief of Police and Fire Department of the Township of Harrison as required by law.

2. If the rain date that is established is beyond the ninety-six (96) hours limit, fireworks will be returned to the site twenty-four (24) hours prior to a new date of fireworks display.

3. This resolution shall take effect immediately.
