Section 36A – Emergency Services Cost Recovery

CHAPTER 36A

EMERGENCY SERVICES COST RECOVERY

§36A-1. The City hereby establishes a cost recovery program which allows the City to be reimbursed, to the extent legally permissible, by those individuals utilizing emergency services provided by the Fire Department. The fees are established in Section 36A-2.

§36A-2. The following fee schedule shall apply to the Fire Department cost recovery program as required by the above section, 36A-1:

Standby/Hazard Control/Cleanup - Minor: \$145.00

Minor spill control

Fire hazard precautions

Scene safety

Battery disconnects

Debris cleanup

Accidents in which occupants may have been assessed but signed medical treatment waivers denying medical treatment and/or transport.

Standby/Hazard Control/Cleanup - Major: \$360.00

Significant spills resulting from tank leaks

Major fire hazard precautions

Vehicle stabilization procedures

Vehicle disentanglement

Multiple personnel response

Light Rescue Service: \$355.00

General Patient handling

Immobilization, treatment and removal from vehicle without need for hydraulic or other power tools.

Need for Standing Takedown immobilization procedures for occupants located outside of vehicle.

EMS treatment provided to patients struck by another vehicle.

Heavy Rescue Service: \$585.00

Patient extrication procedures requiring the use of hydraulic, pneumatic or electric power tools.

Multiple patient removal and/or treatment that requires extended on-scene time and extra personnel.

HAZMAT RESPONSE

Hazardous Material Control/Standby: \$400.00 to \$1,050.00

Incidents involving commercial trucks, vans and motor-carriers.

Large amounts of spilled or released product.

Requires extra personnel and equipment response for extended period of time.

If a DEC number is issued for a spill, the responsible party will be billed direct (not the auto insurance) for all actual costs including costs to other department and agencies. In this situation, if there is a need for other types of service, then the auto insurance may be billed also.

During the course of constructing the steel sheet pile wall, actual geotechnical conditions regarding refusal depths were greater than anticipated. The second phase of the marina construction next year requires us to dredge to an elevation that would put the stability of the new wall in jeopardy by increasing its overturning moment. To counteract this force I ordered that tie-backs with deadmen be installed behind the wall underneath the existing parking area.

Accordingly, I respectfully request that the Common Council approve Change Order 1 for the Gratwick Riverside Park Marina Upland Improvements Project in the amount of \$37,794 to Pinto Construction, 1 Babcock St., Buffalo, NY 14210, increasing the contract cost from \$179,119 to \$216,913; authorizing the Mayor to sign said change order subject to review by the City Attorney.

Change Order No. 3 is a credit in the amount of (\$32,250) representing the unused contract quantities.
