

Security Incentive Scheme

To support residents in taking an active role to deter burglaries, the Town of Victoria Park is offering a partial subsidy to owners/occupiers for the installation of home security devices.

Conditions:

1. Security devices must be provided and installed by a registered business with a Security Agents License.
2. Applications are not eligible for improvements, repairs or additions to existing devices.
3. Property investors are restricted to claim a maximum security rebate of \$200.
4. One application per residence considered each financial year.
5. The Town provides no guarantee that a security rebate can be provided to all applicants if the allocated budget is fully expended prior to the end of the financial year.

Rebates

The following table lists items available for the rebate and the rebate amount claimable:

Item / Device	Rebate	Rebate + Discount for Pensioner Concession, Health Care or WA Senior Card holders only
Home intruder alarm	\$200	\$250
Door deadlocks (per lock)	\$30	\$50
Keyed window locks (per lock)	\$25	\$30
Security sensor light	\$40	\$55
Security screen door (per door)	\$70	\$110
Security window screen (per window)	\$35	\$50
Maximum home security rebate	\$200	\$250

Additional Security Incentive Scheme Subsidies

Vehicle Immobiliser: Residents can apply for a subsidy towards the purchase and installation of a vehicle immobiliser for a private/family vehicle pre-dated 1999.	Max. \$40 (or \$50 with concession)

Step-by-Step Application Instructions

STEP 1 – Claiming a Security Incentive Scheme rebate:

Forward the completed *Security Incentive Scheme Application* to the Town along with:

1. A copy of the written quote for the required security item/s, from a registered business with a Security Agents License.

Or

2. A copy of the receipt for full payment of the installed security item/s, undertaken by a registered business with a Security Agent License and within 12 months of the receipt date.

And

3. A copy of the Home Occupier's valid Pensioner/Health Care/Seniors Concession card (where applicable).

STEP 2 – Lodge your application:

STEP 3 – Confirmation:

1. Application with written quote:
The Town will review your application and advise you in writing of the outcome of your application, including the total rebate payable after installation.

Or

2. Application with a copy of the receipt:
The Town will review your application and advise you in writing of the outcome of your application, including a cheque for any rebate payable.

Helpful hints:

- To ensure that you get the best price, obtain a minimum of three quotes.
- Ensure that your supplier is a registered business with a Security Agents License. This information should be found on the quote/invoice from your chosen supplier.
- Don't be pressured to sign a contract on the day.
- Ask your insurance company if they offer security item discounts to members.
