

INSTRUCTIONS FOR COMPLETING AFFIDAVIT FOR BONA FIDE LEGAL CHANGE OF RESIDENCE - 2012-13

FOR STUDENT(S) _____ TRANSFERRING FROM

Exception 1 to Transfer Bylaw 4-7-2 allows the Commissioner's Office to consider restoring eligibility to a transfer student whose <u>parents</u> (note: plural) have made a "bona fide legal change in residence from one public school district to another public school district" to become eligible to participate in interscholastic athletics insofar as the transfer bylaw is concerned. <u>The rationale for this exception centers on the idea that the change of residence</u> **compelled** the student to transfer. Bylaw 4-6-1 defines what constitutes a "bona fide legal change of residence" and the factors to be examined in making this determination. To be certain, merely signing a lease agreement for an apartment in the new district does not constitute a bona fide legal change of residence. <u>Note: If only one parent in an intact family "makes the move," a presumption is created that "the move" does not meet the criteria of this Exception 1. Both parents, if married, must make the move into the new school district. If the parent completing this form is single either due to divorce, dissolution, never having been married or is in the process of having the marriage legally terminated, please provide an explanation on Item #4 of the affidavit.</u>

To further assist schools and parents alike with this determination, the OHSAA has developed an *Affidavit of Bona Fide Change of Residence* to be executed by parents when making such a change of residence and resulting transfer. Please keep in mind that as a result of the transfer, the student becomes automatically **ineligible** for interscholastic athletic competition until declared otherwise by the Commissioner's Office. Exception 1 vests with the Commissioner's Office some discretion to determine whether the purported new residence is indeed a "bona fide residence" and whether the change in residence/transfer was athletically motivated. The *Affidavit* is a key tool in assisting the Commissioner's Office with this evaluation.

For the most part, this *Affidavit* is fairly self-explanatory. Each of the 28 affirmations contained within this *Affidavit* requires the person(s) executing the *Affidavit* to complete each statement/paragraph by either inserting the applicable information, circling the appropriate "does/does not" or inserting affiant's initials where called for. All 28 paragraphs must be honestly and accurately completed by the affiant and the information recorded in the *Affidavit* must be independently verified by the school's administration *before* the transmission of this *Affidavit* to the Commissioner's Office for consideration.

The duty of due diligence on the part of the school administration not only extends beyond the duty to independently verify the information recorded in the *Affidavit* prior to submission to the Commissioner's Office but also extends for the entire year for which the family is obligated, under the exception, to maintain this new residence. All of the measures that a reasonably prudent person would undertake to satisfy oneself that indeed the majority of life's major activities for that family are taking place at this new residence are expected to be taken by the school with respect to each transfer student for whom this exception has been granted. This would include, but is certainly not limited to, periodic residency checks that yield meaningful results (and documented in a residency check log), copies of utility bills that demonstrate utility usage commensurate to expected usage for that family size/time of year, checking account/checks bearing this new resident address, appropriate food and clothing stored within the residence, appropriate number of bedrooms/beds for the number of occupants and so on.

The penalties for providing false or misleading information in this *Affidavit* to the Commissioner's Office can be severe for the student involved and perhaps even the student's team. The penalties to the school for failure to do its due diligence in verifying the veracity of this information either initially or throughout the year can be equally severe. This Exception 1 is intended to be an accommodation to students who have moved and as a result of this move have had to transfer schools. This Exception 1 was never intended to be a loophole to circumvent the transfer bylaw and the one year "sit out" provision contained therein.
