

Yavapai County Food Safety Industry Council Nomination for Membership

You have been recommended to represent Yavapai County as a member of the Yavapai County Food Safety Industry Council (FSIC).

The FSIC represents members of the food service industry, consumers, the University of Arizona, and Yavapai County Environmental Health Unit. The FSIC has 5 Board of Supervisors (BOS) appointed voting members from each BOS district, with a total of 15 voting members. Four members from each district represent the industry and one member is a consumer. For each BOS district two members serve a three-year term and three members will serve a two-year term.

The council meets every other month for 2 hours (9:30-11:30 am) with remote video locations at Prescott YCCHS, Prescott Valley YCCHS, and the Cottonwood BOS. The schedule of meetings is established for a one-year period. Members are expected to attend at least 3 of the 6 scheduled meetings per year.

The purpose of this Council is to serve in an advisory capacity to the University of Arizona Cooperative Extension and the Yavapai County Community Health Services, Environmental Health Unit, to provide input and recommendations to address food safety in Yavapai County. To include but not limited to the following areas:

1. Identify food safety education needs of the food service industry and consumers, and recommend education programs.
2. Assess current food safety education program offerings and county impacts.
3. Review existing and proposed food policies in the Yavapai County Health Code and make recommendations to the Yavapai County Community Health Services, Environmental Health Program.
4. Serve as a communication avenue between regulatory, academic and food service entities.
5. Provide input directly to the Yavapai County Community Health Services, Environmental Health Unit, related to food safety issues and needs.
6. Provide input on the content and quality of the Food Safety Newsletter.
7. Promote and maximize food safety.

All nomination applications submitted will be considered by the FSIC. If approved by the FSIC the nomination will go forward to the appropriate Yavapai County District Supervisor for initial approval prior to being officially submitted to the BOS for final endorsement.
