


**ORDINANCE NUMBER 65, 2007**

Video Conferencing Project**



As you are aware, County Administration, County Council and the Courts have been working the past several months on the Magisterial District Judges Video Arraignment Project. It has recently come to my attention that the project is under funded. Basically, I was under the assumption that when Version and Time Warner were contracted to install high speed internet access, nothing else would be required. Unfortunately, they provide access in a business application to the building, and an electrician must then be hired to run it from the point of demarcation to the Magisterial District Judges' Office.

Newco Electric has provided the attached proposal of \$9,850.00 to run the line inside each office. I am requesting an appropriation from the General Fund to finish this project. I apologize to the County Administration and Council for this error.
