Instructions for the Use of LRAPA Form ASN-4 Waste Shipment Record

This form is to be used as a permanent record for tracing asbestos waste materials from removal site to final disposal. The asbestos rules which apply to waste disposal are found at the Lane Regional Air Protection Agency "Rules and Regulations", Section 43-015-14.

Waste Generator Section

(Numbers below correspond to the numbers on the form)

- 1. Enter the name and address of the facility where the asbestos wastes will be generated.
- Enter the name, address, and phone number of the operator (or licensed asbestos contractor or certified facility worker)
- 3. Enter the name, address and phone number of the disposal site.
- 4. Describe the materials being removed.
- 5. List the total number if containers and their type. Also enter one of the following container codes used in transporting each type of asbestos material. (specify any other type of container used if not listed below):

DM Metal drums, barrels
DP Plastic drums, barrels

BA 6 mil plastic bags or wrapping

- 6. Give an estimate of the total cubic yards of material.
- 7. Provide any information or instructions on special handling.
- 8. Print clearly the name of the company and the authorized singer. This section of the form <u>must be</u> signed and dated.

NOTE: The waste generator must retain a copy of the complete disposal form.

Waste Transportation

- Transporter #2: Acknowledgment of receipt of materials. Print name and agent name then sigh and date.

12. Discrepancy space. (This space is used if there is a discrepancy between the amount of material received by the landfill and the amount of material listed on the manifest.)

NOTE: The waste disposal site operator must retain a copy of this form.

In addition, asbestos waste disposal regulations require that Waste Disposal Site operators take the following actions:

- Send a copy of this signed Waste Shipment Record to the Waste Generator as soon as possible (and no longer than 30 days) after the waste has been received at the Disposal Site.
- Notify LRAPA immediately by telephone of improperly enclosed or uncovered waste. Submit a written report to LRAPA the following working day, along with a copy of the Waste Shipment Record.
- If you discover a discrepancy between the quantity of waste designated on the Waste Shipment Record and the actual amount received, attempt to reconcile the discrepancy with the Waste Generator. Report in writing to the LRAPA, within 15 days after receiving the waste, any discrepancy that cannot be reconciled. Submit a copy of the waste shipment record with the report, along with the LRAPA-assigned asbestos.
