In June the company continued to review and update its assessment report summarizing work done on the Sackville Property during the winter 2014 drilling program and the completed additional 4 drill holes in May with a total length of 570m. In addition, the Company continues to place all work on the Omega property on hold as it waits for improved market conditions. In the last four years on the Omega Property the Company has completed 117 drill holes (approximately 38,000 metres) with over 16,000 core samples assayed.

In June, the board of directors and management assisted with the developments described in Section 1 above. Management also continued to evaluate the Issuer's existing projects, exploration programs and potential acquisitions or disposition as well as other business development strategies.
