6. New Business:

a. Consideration of recommendation to Town Council of an amendment to the 2010 ATAX Grant for the Art League of Hilton Head Island

Mr. Shay asked representatives of the Art League to explain their amendment request. Cynthia Chiappetta, President of the Art League, asked the Committee to consider amending the part of their 2010 ATAX Grant that pertains to advertising their move to the Shelter Cove Mall. Their move to the Shelter Cove Mall has been cancelled and they would like to use those funds to advertise their move to the Art Center of Coastal Carolina. Because their agreement with the Arts Center was not finalized until late November, 2010, they are requesting the \$10,000 set aside for advertising their move, be extended to also include expenses incurred in 2011. In an effort to adhere to the hearing schedule the Committee delayed voting on this recommendation until after the hearings. (See 6 c.)
