	Every master plumber shall display a sign, plainly visible from the street, at each place where his firm is doing plumbing work. The sign shall give master plumber’s firm name, address and telephone number and shall include letters, at least two (2) inches high and legible, the words “LA. Master Plumber” Number.	Certification from a fire suppression company for fire suppression installation. Work performed or service of an existing fire suppression system other than the company, which has issued the certificate, shall be covered by the contractor’s general liability.
	Each and every vehicle used in the performance of any phase of plumbing shall be lettered similar to that of job display signs. Signs must be permanently attached to both sides of the vehicle.	All vehicles used are to be completely and properly marked on left and right side doors with permanent letters of two-inch minimum height.
