This section does not require the District to be responsible for or defend against claims or damages arising solely from acts omissions of the provider, it officers or employees.

The parties acknowledge that the terms of this agreement constitute the full and final agreement of the parties hereto, superseding all prior negotiations and all prior or subsequent oral agreements. This Agreement may be amended only by written agreement and executed by each of the parties hereto.
