Affidavit of Gratuitous Keep Instructions

PARENT: By allowing a family member/friend to sign an Affidavit of Gratuitous Keep to enroll your child/children in the Chartiers Valley School District, please understand that you are relinquishing all educational rights, and you will not be contacted by teachers or administrators for academic, social, or emotional concerns.

RESIDENT: By signing an Affidavit of Gratuitous Keep, you are agreeing to the following:

- To support the child gratis (without personal compensation or gain)
- To assume all personal obligations for the child relative to school requirements, such as:
 - providing required immunizations
 - finances/fees
 - citations/fines for truancy
 - attending parent conferences
 - attending meetings/hearings concerning discipline
- To keep and support the child continuously and not merely through the school term

In addition to the completed Affidavit, the resident must also provide his/her proof of residency (an original utility bill, original lease or sales agreement).

Failure to comply with any of the above listed items may result in tuition being assessed from the date of enrollment until the current time.

The Affidavit of Gratuitous Keep form must be notarized.

Per 24 P.S. §13-1302, a person who knowingly provides false information in the above statement for the purpose of enrolling a child in a school district for which the child is not eligible commits a summary offense and shall, upon conviction for such violation, be sentenced to pay a fine of no more than three hundred dollars (\$300) for the benefit of the school district in which the person resides or to perform up to two hundred forty (240) hours of community service, or both. In addition, the person shall pay all court costs and shall be liable to the school district for an amount equal to the cost of tuition calculated in accordance with §2561 during the period of enrollment.
