IMPORTANT TOURNAMENT RULES

TEAM CAPTAINS — PLEASE REVIEW BEFORE COMPLETING ENTRY FORM

- 1. This tournament will be open to all female members of any local USBC chartered association in the state of Missouri and will be conducted under the rules and regulations of the United States Bowling Congress. Non-members who reside in the jurisdiction of these associations who are not members of another state association can become eligible by the purchase of a USBC membership card. A USBC member who is a non-resident of Missouri may participate in the tournament by paying the local association dues in the association where the tournament is being hosted. Only one such member can be on any team roster, and such bowler must be on a team roster in order to be eligible for doubles and singles events.
 - a. Bowlers may bowl only once in each event in this tournament.
 - b. Not more than two PWBA players on a four-person team and not more than one such player in a doubles pair.
- 2. All entrants will be handicapped 80% of the difference between their highest certified league average and 210 for singles, 420 for doubles, and 840 for team. All averages must be established in a USBC certified league and will be used in the following order:
 - Previous season's highest (standard or adjusted sport) in any association area. This includes those established in USBC Youth competition.
 - If no previous season average, the entrant's highest current average as of January 1, 2016. (MUST SUPPLY INDIVIDUAL BOWLER RECORD OR LEAGUE STANDING SHEET WITH AVERAGE ON JANUARY 1, 2016).
 - c. If neither of the above, use the highest current season average at the time of participation, based on 21 games or more. (MUST BRING AN INDIVIDUAL BOWLER RECORD, CURRENT LEAGUE STANDING SHEET, or provide the ability to check averages on the internet AT THE TIME OF BOWLING).
 - d. If none of the above, bowler will bowl scratch at 210.
- LATE ENTRY: Allowed subject to availability of lanes up to one day before squad. Money order or cash only accepted for fees. Late fee of \$5 per person will be assessed for entries postmarked or submitted on or after February 12, 2016.
- 4. USBC Rule 319a3 will apply. Rule 319a2 does not apply (10-pin rule).
- DIVISION CLASSIFICATIONS: Division 1: Team 600 and up, Doubles 300 and up, Singles and All-Events 150 and up. Division 2: Team 599 and below, Doubles 299 and below, Singles and All-Events 149 and below.
- 6. ENTRY FEE: Each event is \$22 per person. (Doubles is one event, Singles is a separate event—must enter both.) All-Events is an additional \$2 per person: entry optional. ALL FEES MUST ACCOMPANY ENTRY FORM. Any entrant may pay the \$2 All-Events fee and be eligible for the All-Events prize fund on anticipation of bowling all three events.
- 7. SUBSTITUTES will take the position of the bowler replaced and no rearranging of the line-up will be made. Substitutes MUST have written verification of average (SEE RULE 2.) All substitutions should be made at least ONE HOUR prior to squad time. A substitute will not be required to reimburse the original entrant with the entry fee paid nor shall the substitute be expected to give the original entrant any prize money or trophy she may win. If a substitute is used for a bowler who has paid the All-Events fee, the sub must bowl for the same person in all three events to be eligible for an All-Events prize.
- 8. NO refunds will be made after schedule is accepted. Schedule will be considered accepted unless refused within ten days of postmarked confirmation.

 NO re-arranging of line-up for Team or Doubles will be permitted. Switching players from one Team or from one set of Doubles scheduled to bowl on the same squad will not be allowed. Pacers will not be allowed.

10. DOUBLES entries must be complete 2 or 4 women.

- TEAMS wishing to cross lanes shall submit entry forms and fees in the same envelope along with <u>WRITTEN REQUEST</u> to cross lanes and a <u>NO-</u> <u>TATION</u> on each entry form also stating request.
- 12. RESERVATIONS will be accepted. Full fees and completed entry forms must be forwarded to the Missouri State USBC Tournament Director on or before January 12, 2016.
- 13. We reserve the right to move entries if squads cannot be filled.
- 14. TEAM captain will collect her team members' USBC cards and check in ONE HOUR before squad time at Team Event. Doubles partners will check in together at least ONE HOUR before squad time at the Doubles/ Singles event.
- 15. BOWLERS are asked to wear suitable attire when participating in this tournament. Skirts and slacks are preferred. Short shorts ARE NOT considered suitable attire.
- 16. MISSOURI State USBC will not furnish bowlers for teams or doubles.
- 17. Teams or individuals failing to appear at their scheduled time to bowl may start in their regular turn, coinciding with the rest of the squad at the discretion of the Tournament Director. Those who do not show, forfeit their place and entry fees. Any player or team arriving late shall begin play with the score counting beginning with the frame then being bowled.
- 18. Any entrant appearing at her scheduled time of bowling who appears to be under the influence of intoxicating liquors or drugs, or any entrant who willfully delays the normal progress of the game, or any entrant whose conduct on the lanes is considered objectionable, shall be removed immediately from the lanes and tournament, whether a qualified substitute is available or not.
- 19. Violation of USBC or tournament rules will result in disqualification.
- 20. A tournament game or frame(s) within a game irretrievably lost in the scoring process may be re-bowled at a time set by the Tournament Committee.
