\_\_\_\_\_ Tuition is broken down into monthly payments due on the 1<sup>st</sup> of each month. An account becomes past due on the 15<sup>th</sup> day of the month. A \$20 late fee will be assessed. If the account becomes 30 days past due, the swimmer will not be allowed to swim in practice or meets until payment is made in full. Full Season or Annual payments are non-refundable.

\_\_\_\_\_ Annual and Seasonal Required Fees Include:

- **Pool Registration Fee:** \$80/Family (September-February sign-up), or \$50 after March 1<sup>st</sup> (March-August sign-up)
- **USA Swimming Registration:** \$69/Swimmer (September-February sign-up), or \$45 after March 1<sup>st</sup> (March-August sign-up)
- **Seasonal Park & Rec Fees (Novice and Age Group swimmers only):** \$55/Swimmer (September 1<sup>st</sup> and March 1<sup>st</sup>)

\_\_\_\_\_ Attendance at USA meets is strongly encouraged and expected when JTSC is the host team. *These meets are in addition to Park/Rec meets.* Fees for the USA meets will vary. Meet Fees are due on the 1<sup>st</sup> day of the month following the date applicable fees are charged to the account regardless of swimmer's attendance at the meet. No refunds will be given, no exceptions. Information in regards to upcoming meets will be sent via email and available online.

\_\_\_\_\_ Online payments for tuition and all other fees are preferred and may be made via the website by clicking on the "Make a Payment" tab at the top of the Homepage. If writing a check, make **checks payable to "Jenks Community Education" or "JCE"**. Note the swimmer's name and purpose of payment (*e.g. Jane Smith/July Tuition, Stars & Stripes*) in the Memo of the check. If payment is returned due to non-sufficient funds, a \$25 service charge will be assessed to the member's account.

\_\_\_\_\_ JTSC will cancel practice when Jenks Public Schools classes are canceled due to inclement weather conditions. JTSC will be closed due to school breaks and holidays on the following dates: 9/7, 10/15, 10/16, 11/25, 11/26, 12/24, 12/25, 12/26, 12/31/2015, and 1/1, 1/2, 1/18, 3/14-3/18/2016. No tuition credit will be given for those days since ample make-up practices are offered throughout the year. JTSC does not prorate months, nor charge more for longer months. It is sometimes necessary to close additional practices due to other JTSC or Aquatic Center activities. \_\_\_\_\_ This contract may be terminated by the parent/guardian by submitting written notification in the form of email or letter to the Club Coordinator, Diego Henao ([diego.henao@jenkssps.org](mailto:diego.henao@jenkssps.org)) on or before the 20<sup>th</sup> of the month preceding the cancellation effective date. If notice is received after the 20<sup>th</sup>, the full month's tuition will be invoiced and due upon receipt. (*e.g. Written notifications of cancellations effective January 1<sup>st</sup> must be submitted by Dec. 20<sup>th</sup>*)

\_\_\_\_\_ It is the parent/guardian's responsibility to stay informed of all meets, events, and closings, by reviewing emails, the online calendar, and by referring to the website to receive important, updated information.

\_\_\_\_\_ In the event of default, Jenks Community Education is entitled to employ an attorney or collection agency to enforce the Club's rights under this contract.

## JTSC Parent Participation Contract

Parents are required to participate with the team 15 hours per season and at two USA Home Meets (regardless of swimmer participation). *A fee of \$20 for each hour, and \$40 for each meet not fulfilled will be assessed on Feb 28 and August 31 or prorated for any swimmer withdrawing mid-season.* Any family member or friend over the age of 14 may help towards participation hours. Attendance at parent meetings will count for 1 hour of participation per meeting.

**I understand that being accepted onto the Jenks Trojan Swim Club team requires "Participation Hours" and further understand that my account will be assessed \$20 per hour per season for each hour not fulfilled.**
