SUBJECT: LAW ENFORCEMENT TRUST FUND PURCHASES

I am requesting to utilize funding from the City's Law Enforcement Trust Fund to purchase the following items in accordance with Section 932.7055 of Florida Statutes and the City of North Lauderdale purchasing policies.

North Lauderdale Recreational Foundation **\$5,000**

The North Lauderdale Recreational Foundation, a 501c3 non-profit corporation, provides City residents with alternatives to gang membership, hanging out on the streets, an environment of crime and drugs and other general mischief normally a part of urban family life. By providing a wide range of programs and support to the youth of our community, their efforts impact the lives of our residents in a very positive way. Our funding request will offset the costs of operations, staff and equipment. The use of trust fund monies is limited to those that assist in crime prevention in various ways. This allows BSO to give back to the community dollars confiscated from drug dealers and criminals.

Boys and Girls Club of North Lauderdale **\$5,000**

The Boys and Girls Club of North Lauderdale is responsible for providing a wide range of programs and support to the youth of our community. Their efforts certainly impact the lives of our youth and provide them with an opportunity to avoid an environment of crime and drugs. The funding requested will offset the costs for annual membership to the club for North Lauderdale youths.

RECOMMENDATION

The City Administration and the Broward Sheriff's Office are recommending the Commission's consideration and approval of the attached resolution authorizing an expenditure in an amount not to exceed \$10,000 from the Law Enforcement Trust Fund for the support of the North Lauderdale Recreational Foundation and funding to offset the costs for annual membership for the Boys and Girls Club.

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA, APPROVING THE RECOMMENDATION OF THE CITY ADMINISTRATION AND THE BROWARD SHERIFF'S OFFICE AND AUTHORIZING AN EXPENDITURE IN THE AMOUNT NOT TO EXCEED \$ 10,000.00 FROM THE LAW ENFORCEMENT TRUST FUND FOR THE FUNDING OF THE NORTH LAUDERDALE RECREATION FOUNDATION AND THE BOYS AND GIRLS CLUB OF NORTH LAUDERDALE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Broward Sheriff's Office and the City Administration recommend the use of the Law Enforcement Trust Fund for support of crime prevention programs as set forth in Section 1;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF NORTH LAUDERDALE, FLORIDA:

Section 1: That the City Commission of the City of North Lauderdale, Florida, be and the same does hereby approve the recommendation of the City Administration and the Broward Sheriff's Office and authorize the expenditure of \$10,000.00 for support of the North Lauderdale Recreational Foundation and funding to offset the costs for annual membership for the Boys and Girls Club.

Section 2: That the total cost shall come from available funds held within the City's Law Enforcement Trust Fund in accordance with Section 932.7055 of Florida Statutes.

Section 3: That all items purchased using Law Enforcement Trust Fund will be the City of North Lauderdale's property, if applicable.

Section 4: That this Resolution shall take effect immediately upon adoption.
