- b. Updated SOI (IMB, OAA);
- c. UN Personal History Profile or the UN P-11 Form (new format);
- d. Certificate of completion (any UN related trng/crse/sem);
- e. Clearances (DLO; Accounting & G2, PA). The purpose reflected in the clearance should be for UN deployment;
- f. Latest PFT result administered by SSC, ASCOM; and,
- g. Officer's Appraisal Report (OAR) from last two (2) Commanders.

4. Tentative schedule of selection/deliberation of candidates for the said UN deployment will be on **24 November 2015**.

5. Non-submission of names on the target date will mean negative recommendees. Further, submission of recommendees after the target date will no longer be entertained by this Headquarters.

6. Be guided that recomendees for the above-mentioned post should meet the requirements as prescribed by the United Nations. Further, nomination does not constitute guaranteed deployment unless confirmed by the United Nations Department of Peacekeeping Operations and upon receipt of formal invitation from the Department of National Defense, through the Department of Foreign Affairs of the Philippine Permanent Mission in New York.
