REQUIRED SUBMITTALS

SUBMIT A PLAT OF SURVEY INDICATING THE EXACT LOCATION OF THE PROPOSED POOL, INCLUDE DIMENSIONS TO ALL PROPERTY LINES, AND DIMENSIONS TO ALL BUILDINGS AND STRUCTURES. IF THE YARD IS FENCED SHOW THE LOCATION OF THE FENCE & GATES, INCLUDE THE HEIGHT OF THE FENCE AND THE SPACE BETWEEN PICKETS OR RAILS.

INDICATE THE EXACT DISTANCE FROM ANY OVERHEAD OR BURIED UTILITY LINES.

INDICATE THE LOCATION OF ANY PUMPS, HEATERS, ETC.

IF THE YARD IS NOT FENCED INCLUDE A COPY OF THE CONTRACT FOR THE FENCE AND A COMPLETED FENCE PERMIT APPLICATION . THE FENCE MUST BE INSTALLED BEFORE WATER IS ADDED TO THE POOL. A TEMPORARY FENCE, A MINIMUM 4' HIGH, MUST BE IN PLACE DURING CONSTRUCTION AND REMAIN UNTIL THE PERMANENT FENCE IS INSTALLED. ALL FENCES MUST HAVE A SELF-CLOSING, SELF-LATCHING GATE AND THE LATCH MUST BE A MINIMUM OF 4' ABOVE THE GROUND. THE MINIMUM HEIGHT OF THE REQUIRED FENCE IS 5' ABOVE GRADE. OPENINGS IN THE FENCE, EXCEPT FOR GATES, SHALL BE NO GREATER THAN 4".

IF THE YARD IS NOT FENCED THE PROPERTY OWNER SHALL SUBMIT TO THE VILLAGE AN UNCONDITIONAL, IRREVOCABLE LETTER OF CREDIT IN A FORM ACCEPTABLE TO AND IN FAVOR OF THE VILLAGE, ISSUED BY A FINANCIAL INSTITUTION ACCEPTABLE TO THE VILLAGE OR CASH OR CERTIFIED CHECK IN THE SUM OF ONE HUNDRED TEN PERCENT (110%) OF THE COST OF THE PROPOSED FENCE TO SECURE A TIMELY COMPLETION OF THE REQUIRED FENCE.

INSPECTIONS ARE REQUIRED, BEFORE BACKFILL, BEFORE COVERING ANY ELECTRIC, BONDING & BEFORE POURING ANY CONCRETE. A FINAL INSPECTION IS REQUIRED AND THE REQUIRED FENCE MUST BE INSTALLED PRIOR TO AN OCCUPANCY PERMIT TO USE THE POOL IS ISSUED.
