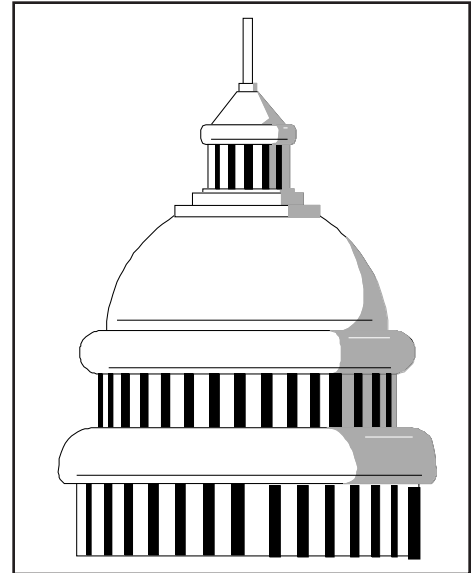

## The Corry Report THE EQUAL JUSTICE FOUNDATION REPORT

The Equal Justice Foundation in Colorado Springs, Colorado, advocates for veterans who, largely as a result of their injuries, have run afoul of the law. The EJF performed a study in 2011 of some 3200 veterans and active-duty military who were arrested and booked into the county Criminal Justice Center that year.

They found that veterans are being treated like criminals instead of people with psychological or physical injuries.

A criminal conviction often makes it impossible for veterans to obtain employment and frequently devastates families and children. The injuries are plainly a factor in increased rates of homelessness, suicide, and homicide

## VIEW FROM THE CHARTHOUSE

During the Vietnam War, a million seafarers manned and supported our US Navy's thousand ship fleet. USFSPA provisions didn't play a role in their divorce actions, because they didn't exist. During this 10-year War, unit commanders reported three self-inflicted (aka suicide) deaths every month. Now, they report upwards of four of these tragic deaths every week!

Single personnel account for 30% of the Pentagon's military personnel self-inflicted (aka suicide) deaths. This suggests, their "Premarital Interpersonal Choices and Knowledge" (PICK) briefings are effective. The remaining 70%, leave dependent family members in the Pentagon's care.

Our nation's divorce industry has been feeding at the USFSPA divorce trough for over 30 years. To them, "a divorce is a di-

vorce." The US Army once linked military personnel self inflicted deaths to their marital problems, before the Pentagon added almost every imaginable interpersonal relationship (to cloud this issue)? Once the military marriage knot is tied, our nation's divorce industry is poised to intervene: What they offer dependent military spouses is seductive, to say the least. USFSPA provisions define military retired pay as court ordered jointly earned marital property, alimony, and/or child support, not necessarily in that order.

State legislators claim USFSPA amounts to an unfunded federal mandate. Arizona and most recently, Wyoming, stopped USFSPA jointly earned marital property provisions in their tracks, where a divorcing disabled veterans compensation is con-

cerned. California inspired these noble actions, however, the political climate in this State did not allow their Legislators to prevent former dependent military spouse marital property award indemnification.

In Indiana, divorcing dependent military spouses cannot claim their sponsors military retired pay as jointly earned property entitlement, unless they are also "fully vested." Puerto Rico has never recognized USFSPA provisions.

I applaud the Pentagon for calling on Congress to adopt its "thank you for your service" universal defined contribution military retirement system proposal. Seven in 10 military personnel suicide casualties are survived by their military dependents.

I urge my fellow USFSPA casualties to join me, each in our own legislative districts and ask our State and Congressional Legislators why all in-processing military are not briefed, regarding the potentially deadly role USFSPA provisions play in their divorce actions. These arguably life-saving briefings are long overdue.

**The Mass Reformed Alimony laws** have been in effect since March 2012. The MAR team is now fighting the family law consortium which is "finding it difficult to financially survive" and is rather "frustrated" by the reform.

**I'm asking the IRS** to prevent Former Dependent Military Spouses from fraudulently claiming the state income tax full/partial military retired pay exemption benefit allowed by 29

states, directing DFAS to use Form 1099-MISC instead of Form 1099-R, to report court ordered Former Dependent Military Spouse payments. Use of Form 1099-MISC will stop the former military spouses from claiming a state income tax exemption benefit, specifically prohibited by 10 USC 1408(c)(2). It must be made crystal clear that military retired pay is **CURRENT INCOME**, just as if the "retiree" were still on full active duty. The use of the words, "pension" or "retirement plan" **MUST** be stopped!

among veterans.

Another startling find of the EJJF study is that while arrests of civilians tapers off sharply after age 30, arrests of veterans continues steadily regardless of age. Virtually all the inmates in the Criminal Justice Center over 50 are veterans and so the county jail effectively becomes an Old Soldiers Home. Available data make

it evident that veterans who remain in El Paso County after their first arrest will keep getting arrested over and over again.

These veterans are bringing back a psychological plague that is not being properly or fully diagnosed, that is not being addressed at the critical time to prevent more harm and violence, and is spreading to family and friends. Evidence in the EJJF report makes it clear that the epidemic today will echo down

the decades until at least mid-century. The repercussions are magnified by Iraq and Afghanistan veterans who have endured multiple combat tours and survived injuries that would have been fatal in previous conflicts.

Advances in battlefield medicine need to be matched by treatment of all types of injuries, psychological as well as physical, once a soldier returns home. We owe our veterans nothing less.

# The Thole Report

Whether you are contemplating a divorce, you might want to pay attention to the latest moves on the part of the Dept of Defense as it pertains to removing or reducing special pays. This also includes bonuses for various MOS/AFSC (career specialty codes) in all the services. Hazardous duty pay has been eliminated for a number of areas. There are no bonuses for re-upping in certain career fields; in fact, many airmen, for one, are going to have to re-train to another field if they wish to remain on active duty.

Too many military personnel and their families have come to rely on bonuses, special pays, and any money received over and above their basic pay and benefits (BAS/BAH) for day-to-day living. Just as in the civilian world, this is NOT a good practice and you need to wean yourself off using that money for other than saving for a rainy day. Saving for retirement, especially when you are younger than 50, just does not only not appeal to many people, it isn't even on their radar screen.

If the bulk of your spending is on nice-to-have (vs. absolutely necessary to have) things, then you need to have a down-to-earth talk with your-

self and your family. Such rampant spending needs to stop. And you might ask why? Because any of those special pays can stop just as abruptly as the rain. To rely on them is financial suicide.

When the military member is planning to leave the service, both parties (husband and wife) seem to think they will be able to live just as well as they did when married. Folks, you are living in la-la land if that is your thinking. Get that help now if your spending is out of control.

How to tell if your spending is out of control? This is an easy one: If you are making the minimal payment on your credit, your spending is out of control. If you are making any recurring monthly payment on a balance on a card, your spending is out of control. If you cannot pay off your credit card in whole every month, YOUR SPENDING IS OUT OF CONTROL. Period. (And I would bet other things in your life are also out of control.)

Divorce is often, sadly, a financial disaster for both parties, but even more so for the non military spouse. Start planning now, so that when you start your new life, you can do it without being stressed out about your finances.

## SUSPECTED USFSPA 1099-R FRAUD ALERT

**AL, AR, AZ, CO, CT, DE, HI, IA, ID, IL, IN, KY, LA, MA, MD, MI, MO, MS, MT, NC, NJ, NY, OH, OK, OR, PA, SC, WI and WV, exempt military retired pay from taxation:** We recently discovered, "it is extremely difficult" for these State Tax Departments to determine if a subject IRS Form 1099-R is reporting:

**a.** tax exempt compensation, received by resident military personnel who are serving indefinitely, at the will and pleasure of their respective service secretary, or

**b.** non tax exempt payments received by resident former dependent military spouses, pursuant to a USFSPA divorce actions, where 10 USC §1408(c)(2) provisions apply.

Can you identify a former dependent military spouse, resident you believe has or is committing this USFSPA related fraud? If so, please consider sharing their contact information with their concerned State Tax Department.

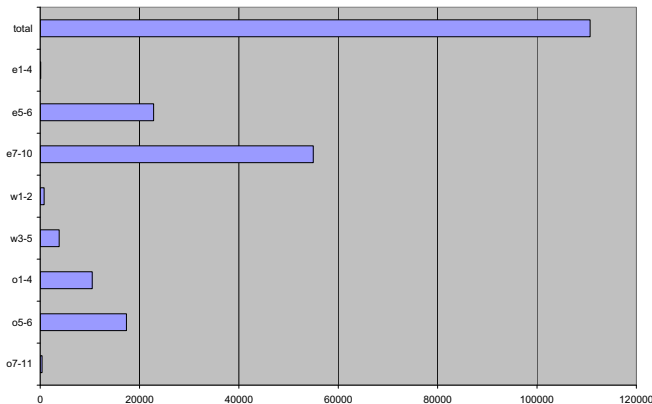

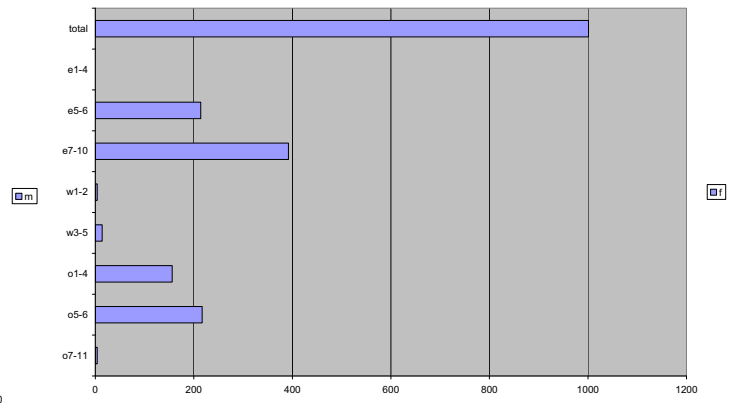

# THE IRS CRACKS DOWN ON ALIMONY

Divorce is about to get even more miserable: The Internal Revenue Service says it is devoting more scrutiny to taxpayers' claims about alimony.

Under the tax code, the spousal support known as alimony is deductible by the payer and taxable to the recipient. So if Bob

pays Carol \$25,000 of alimony a year, he can write it off and she is supposed to claim it as income. By contrast, payments for child support and property settlements aren't deductible - although they aren't considered income, either. But guess what? Divorced couples don't agree about alimony any more than other issues. Earlier this month, the Treasury Inspector General for Tax Administration, an IRS watchdog also known as Tigta, issued a report identifying a large tax gap between alimony deductions by payers and the

corresponding income claimed on ex-spouses' returns.

In response to the report, the IRS said it has adjusted current audit filters to catch more high-risk returns and is developing other strategies to address the alimony tax gap. In addition, the agency said it would work to make sure that penalties are assessed when a taxpayer who deducts alimony doesn't provide a valid tax ID for the payee. The IRS said that enforcing alimony rules would remain part of the audit process, however. In other words, the agency isn't planning to impose automatic rejections of e-filed returns based on an incorrect tax ID - as it now does when divorced parents each claim an exemption for the same child.

David Lifson, a certified public accountant at Crowe Horwath in New York, says divorce documents are often full of legalese that doesn't spell out what's tax-deductible and what isn't. For example, he says, divorce agreements often don't use the word "alimony" but refer instead to "maintenance. Divorce negotiations are so fragile," he adds, "that advisers hesitate to ask for anything they don't have to."

Mr. Lifson also cites what he calls "I'll-pay-for-that syndrome" as a source of confusion. That's when the alimony payer provides, say, a free computer or a discounted car and subtracts the value of such items from the alimony - while the recipient forgets to pick it up as income. Then again, he says, "I suspect there's lots of cheating."


