Information may be accessible or protected as required under the provisions of the *Access to Information Act* or the *Privacy Act*. Failure to provide all necessary information could result in the application being refused or its processing delayed.

INSTRUCTIONS FOR COMPLETING AN APPLICATION FOR A RAILWAY OPERATING CERTIFICATE (ROC)

The *Railway Safety Act* requires railways to have a Railway Operating Certificate (ROC) to operate or maintain a railway, or to operate railway equipment on federally-regulated track. To obtain a ROC, applicants must:

- · provide all required information in this application form; and
- meet all Railway Operating Certificate Regulations requirements.

Important Notes:

- 1. Transport Canada will require applicants to redo incomplete or incorrect applications, which could delay delivery of a ROC. This is why we ask you to please contact Transport Canada at railsafety@tc.gc.ca or at 1-844-RAIL(7245) with any questions you may have, before you submit a ROC application.

The instructions below explain what information you must provide in each section of this form.

SECTION 1 - COMPANY INFORMATION

Contact: Identify who the company authorizes to:

- · discuss this application with Transport Canada;
- · clarify information it contains; and
- · provide additional information upon request.

Note: This person should have technical knowledge of the company's railway operations.

Type of Company: It is very important to indicate whether the company is a railway company or a local railway company as defined in the Railway Safety Act.

- A railway company is a federal company that operates or maintains federally-regulated track, and holds a Certificate of Fitness from the Canadian Transportation Agency.
- A local railway company is a provincial railway, shortline, tourist train or light transit rail service that operates equipment on a host railway company's federally-regulated track (e.g. track belonging to the Canadian National Railway Company (CN) or the Canadian Pacific Railway Company (CP)).

Why is this important? Requirements for getting a ROC are different for each type. Depending on the type of company, you must complete or leave blank, certain sections of the application form.

While all applicants must complete sections 1, 2, 5, and subsection 3A:

- · only railway companies must complete subsection 3B.
- only local railway companies must complete section 4.

Note: If you are not completely certain about the type of company you represent, please contact Transport Canada before submitting an application for a ROC.

SECTION 2 - DESCRIPTION OF OPERATIONS

Types of Operations: Check the appropriate box for every type of operation the company proposes to undertake under the *Railway Safety Act*. The boxes you check here determine which subsections you must complete in Section 3 since the company will need different rules depending on the type(s) of operations.

• Operation and maintenance of line work - Only railway companies can check this box and complete subsection 3C if the operations will include the operation and maintenance of line work.

Note: Local railway companies should leave this box blank since the host railway company is responsible for any line work on federally-regulated track.

- Transport of passengers If the operations will include transporting passengers, check this box and complete subsection 3D.
- Transport of freight If the operations will include transporting freight, check this box and complete subsection 3E.

Note: The ROC will only authorize the type(s) of operations you indicate in the application. You must complete a new application if the company wishes to undertake a new type of operation after obtaining a ROC.

Description of Operations: Describe the railway by province and territory, and the operations to be conducted on the railway. Include the following information:

- What: Describe who (e.g. commuters) or what (types of freight) the company will transport, the types of equipment it will operate, what line works the company plans to operate or maintain (railway companies only), and the size of the operations (e.g. number of operating employees, size of locomotive fleet, size of railcar fleet).
- Why: Explain the purpose of the operations (e.g. to provide service to mining projects).
- · Where: Specify geographic area(s) by province or territory, and where provincial or international boundaries will be crossed, if any
- When: Indicate whether operations will be year-round or seasonal (specify which months); and when the company would like to begin operations (except for existing companies already operating on January 1, 2015, who should indicate that they already operate).
- Who: Indicate any other companies that will be involved in the railway operations (e.g. subsidiaries, contracted activities, etc).

Note: Local railway companies must identify the host railway company/companies on whose tracks the local railway company will operate equipment.



SECTION 3 - RULES

To obtain a ROC, applicants must have rules for various subjects related to safety, depending on the type of company (identified in Section 1), and the type(s) of operations (identified in Section 2). Applicants may either become signatory to existing rules (you will find examples in the tables below), or formulate and file new rules on the subjects.

The tables below indicate:

- which rules are required by type of company and types of operations; and
- the corresponding subsections (A-E) to complete on the ROC application form.

To complete the required subsection (i.e. those marked with a check mark), check the box that applies and insert the name of the rule the company has/will have. Leave the other subsections that do not apply (i.e. those marked with an X), blank.

Notes:

- If Transport Canada has not yet approved the company's rules, you must submit them to Transport Canada, who must approve them before the department will assess your ROC application. For information about how to submit rules, please contact Transport Canada at railsafety@tc.gc.ca or at 1-844-RAIL(7245).
- While you may submit rules for approval when applying for a ROC, Transport Canada will consider the application incomplete and place it on hold until it approves the rules.



SECTION 4 - LIST OF INSTRUMENTS

Only local railway companies must complete this section. Railway companies should leave this section blank.

While Transport Canada does not require local railway companies to have rules on fatigue management, medical fitness for duty, or employee qualifications because these matters remain under the jurisdiction of the province, third parties may impose such requirements. Third parties may be:

- · the host railway company (in an agreement);
- · the province or territory (in a law or regulation); or
- · the company (in an internal policy).

Applicants must:

- · list all third party instruments (i.e. documents) that contain safety requirements; and
- · describe any safety requirements they contain, relating to employees, which the applicant must comply with.

Please be specific. It is not enough to simply state the company will comply with all requirements imposed by the host railway company, province or territory. You must explain to Transport Canada what those requirements are, to demonstrate you are aware of, and understand them.

SUBSECTION 4A - AGREEMENTS WITH RAILWAY COMPANIES

Most local railway companies have an agreement with one or more host railway companies to operate equipment on their track. Such agreements often impose safety requirements on the local railway company.

Include only what the host railway company requires in this subsection:

- · Provide the title of the agreement (e.g. agreement between local railway company and railway company);
- · Provide the name of the host railway company; and
- Describe the host railway company's requirements in the agreement that relate to managing fatigue, medical fitness for duty, employee qualifications and training (see the sample ROC application form for examples).

Note: Do not submit a copy of these agreements to Transport Canada, as they may contain confidential information.

SUBSECTION 4B - PROVINCIAL AND TERRITORIAL LAWS

Most local railway companies will be subject to provincial laws and regulations to operate railway equipment in a province or territory. Many provinces have laws and regulations that include safety requirements that apply to railway operations.

Include only what is required by the province or territory in which the company will operate in this subsection:

- Provide the name or title of the law or regulation (e.g. British Columbia Railway Act), and the name of the province or territory (e.g. British Columbia).
- Describe what the province or territory requires for managing fatigue, medical fitness for duty, employee qualifications and training (see the sample ROC application form for examples).

Note: If there is more than one provincial instrument containing requirements for safe railway operations, be sure to list and describe them all.

Be specific. It is not enough to state the company will comply with or abide by any applicable laws and regulations. You must:

- identify the instrument that contains safety requirements for railway operations (i.e. the name of the provincial law or regulation, such as Ontario Shortline Railways Act, 1995); and
- describe what requirements (if any) it contains related to managing fatigue, medical fitness for duty, and employee qualifications. This demonstrates you are aware of, and understand them.

SUBSECTION 4C - OTHER INSTRUMENTS

Local railway companies may also:

- be required to comply with safety requirements imposed by a third party (such as a client); or
- · voluntarily implement safety commitments such as company policy.

Leave this subsection blank if no such requirements or commitments exist, or if they are identical to those you described in subsections 4A or 4B.

Include only what the company itself or a third party (other than the host railway company, province or territory) requires:

- Provide the title of the document that contains safety requirements or commitments (e.g. Local Railway Company Policy), and the name of the party that
 imposes them on the company (e.g. Third Party Company).
- Describe what is required under that document for managing fatigue, medical fitness for duty, and employee qualifications and training (e.g. company policy is to limit shifts to 4 hours since it only operates in the afternoons on a seasonal basis).



SECTION 5 - ATTESTATION

Complete only **one** attestation for the type of company you indicated in section 1 (railway company or local railway company). Leave the other attestation blank.

If the company already has a Safety Management System (SMS) that meets **Safety Management Systems Regulations**, **2015** requirements, insert the word "has" in the last blank. If the company does not have an SMS, insert the words "will have".

The company's Chief Executive Officer (CEO) or most senior officer named in the attestation must sign, date, and indicate where he or she signed the ROC application. Signatures:

- must be original, authentic, and handwritten in ink (blue, preferably); and
- may not be stamped, electronic, or signed by procuration (i.e. by another person on their behalf).
