#### 1. Call to Order

Chair L.A. Daly called the meeting to order at 9:30 am, welcoming new Council Members and observers. She shared her experience as a Member of the transitional Council, and reviewed the work completed by the TC in preparation for proclamation of the *Psychotherapy Act*.

#### 2. Introductions

Council Members introduced themselves to others around the table, outlining their backgrounds and experience that led them to becoming Members of Council.

#### 3. Approval of Agenda

The Chair raised an additional item for consideration with agenda item five.

C-11 Dec 2015 MOTION: Moved by K. VanDerZwet Stafford, seconded by A. Benedetto.

That the agenda for the December 11, 2015 meeting of Council be approved as amended.

#### 4. CRPO Overview

The Registrar, J. Rowlands, reviewed the history leading to creation of the College, beginning with the referral made to the Health Professions Regulatory Advisory Council, the recommendation that the profession be regulated, passage of the *Psychotherapy Act* in 2007, the appointment of the transitional Council in 2009, and lastly the development of regulations. practice standards, and registration processes to allow for proclamation of the Act.

Council reviewed the legislative framework behind a regulated profession, the criteria that would require a practitioner to be registered with the College, and development of a competencybased registration model for registration.

The Registrar also discussed outstanding issues that will impact the College, including possible future consideration of the Registered Mental Health Therapist title, and clarification of the meaning of the controlled act of psychotherapy. The explanation of the controlled act was requested by the Ministry of Health and Long Term Care in order that it could also be recommended for proclamation.

# 5. Motion to Amend Schedule 1 of By-laws (Election Process)

M. Pioro reviewed the role of Executive Committee, and the process set out in Schedule 1 of CRPO's By-laws. He noted that the By-laws allow Council to deviate from the established process for the first election of Executive Committee, as the transitional Council had done in 2009. Prior to the meeting, Council Members were informed that since they did not have an opportunity to become acquainted in advance of the first meeting, nominations would be accepted from the floor with the support of one other Council Member.

In order to make the deviation from Schedule 1 explicit for the first Executive election postproclamation, Council was asked to approve an amendment to the Schedule.

C-11 Dec 2015 MOTION: Moved by K. Marlowe, seconded by L. Rudner.

That Council amend the final sentence of Schedule 1 to the By-laws, by inserting the words "after section 6 of the Act is proclaimed into force" following the words "with the exception of the first election of officers", such that the sentence reads: "The above process shall be followed for every election of officers, with the exception of the first election of officers after section 6 of the Act is proclaimed into force, which may deviate from the above process to the extent deemed necessary by the Registrar."

K. VanDerZwet Stafford introduced a second motion, to create an exception for the term limits of College officers set out in article 5.03. He explained that since it was not the intention of the transitional Council to restrict returning Members from running for a position on Executive if a Member had served as an officer in the past, the amendment would allow each Council Member an opportunity to run for any position on the Executive. M. Pioro clarified that the amendment would give a returning officer who had completed the maximum number of consecutive terms in a particular position, the opportunity to be elected for one more one-year term to that office.

The Chair asked if Council Members held a conflict of interest concerning the motion. C. Cowan-Levine declared a conflict and left the room while Council considered the proposed amendment.

That Council enact as by-law article 5.04:

5.04 – Maximum Term Exception

Article 5.03 does not apply to the full-year term immediately following the first election of officers after section 6 of the Act is proclaimed into force, to an officer who held that office prior to that election.

# 6. Health Regulatory Governance

Deanna Williams provided an orientation to Council about the role of governance in the context of a regulated health profession. She underlined the importance of developing and maintaining effective governance structures for a self-regulated profession, understanding the mandate of a regulatory body versus that of a professional association, and the need to make decisions in a transparent manner to protect the public interest.

# 7. Registration Update

M. McPherson reviewed the total number of applications received, Members currently registered with the College, programs Recognized for the Regular Route, the number of Registration panel meetings held to date, and the number that would take place in 2016. She also reported that the first sitting of the Registration Exam had been set for March 10<sup>th</sup>, and that over 40 Qualifying Members had indicated interest in registering for the exam.

# 8. Quality Assurance Program (Overview & Phase 1 Launch)

L. Marttinen discussed the purpose of the Quality Assurance Program and the legislative framework that supports it. She also reviewed who will need to participate in the program, and what each participating Member will be required to complete. Council was informed that the pilot launch of Phase 1 of the Quality Assurance Program (Professional Development) will take place in early 2016.

#### 9. Committee/ Committee Chair Appointments

M. Pioro reviewed the mandate and expected workload of each of CRPO's committees. Council Members were directed to the proposed slate of committee memberships circulated in the agenda package.
