GENERAL CONDITIONS OF THE CONTRACT**

1. The tender shall be accompanied with EMD as mentioned in shape of D.D. / Pay order drawn on any Nationalized Bank in favour of **The Odisha State Police Housing & Welfare Corporation Ltd. Bhubaneswar payable at Bhubaneswar**, failing which the tender shall be rejected.
2. The tenderer should be a registered firm under Value Added Tax Authority and should furnish copy of the registration certificate along with the paper.
3. The tenders (also called bids) not submitted in prescribed format or in prescribed manner, shall be rejected at the risk and responsibility of bidder.
4. All the information as called for in the tender document should be submitted truly, clearly, legible, transparently, unambiguously and without the use of abbreviations. It shall be submitted in English only.
5. All the crucial figures, like rates and amount should be written in figures followed by words in a bracket.
6. There shall be no over writing in the tender document and other papers submitted. All additions, alternations, deletions and cutting should be initialed with rubber-stamp (or seal) by the same person, who signs the tender document, failing which so, the tender may be rejected.
7. All the rates and amounts shall be quoted in Indian Rupee and shall be presumed to be in Indian Rupee only unless specifically permitted to be quoted otherwise in this tender document.

8. Each page of this tender document should be signed by the bidder with seal in token of having read, understood and accepted the terms and conditions of this contract.
9. Use separate piece of paper where the space provided in the formats in this tender document for submission of information is not sufficient.
10. The tenderer shall stand for guarantee against defective materials / manufacturing defects and workmanship for the work carried out by him for a period of 12 months alongwith extended guarantee of 24 months from its commissioning /handing over & make good /repair/replace the faults during this period without any extra cost, failing which the same shall be got done at the risk and cost of the tenderer.
11. No compensation shall be payable to the contractor for any damage caused by rains , lightening , wind , storm , floods Tornado , earth quakes or other natural calamities during the execution of work . He shall make good all such damages at his own cost , and no claim on this account will be entertained .
12. All information submitted or supplied in the formats of this tender document shall be presumed to be true to the best of knowledge of tenderer.
13. The blacklisted firms shall not be eligible for participating in the tender.
14. The party has to prepare and installed the LED sign Board for all weather conditions. The LED Sign Board should be rugged enough to work, with standing wind, rainfall and other inclement weather conditions.
15. The tenders can be sent by post or courier as well. However, authorities shall not be responsible for any postal delays in receipt of tenders.
16. If the last date for receipt of the tender turns out to be a holiday, it will automatically be extended to next working day.

17. A tender submitted can not be withdrawn. The tenderer or his authorized representative (one person only) will be allowed to be present at the time of opening of tenders. They will not participate in the discussions. Clarification sought, if any may be provided by them.
18. All or any of the tenders submitted can be rejected without assigning any reason thereof. No claim, whatsoever, shall be admissible for the alleged loss/damages suffered by tenderers on account of such rejections.
19. Prices quoted for each item shall be inclusive of all i.e. supply, installation ,commissioning and testing , taxes and duties, excise duty, transportation, loading, unloading, insurance, watch and ward etc.
20. Advance payment /part payment will not be entertained before completion and handing over the work.
21. No claim can be made due to some unforeseen delay for release of payment.
22. Payment of bill will be made only after completion of the work in all respects i.e. supply, commissioning, testing and handing over the work to the authority.
23. Income tax, labour cess tax and other tax as per prevailing rules shall be deducted from the bill .
24. Time is essence of the contract. In case of CONTRACTOR fails to complete the whole work within the stipulated period , and clear the site he shall be liable to pay liquidated damages @ 0.5 % of the value of the contract per week and or part thereof of the delay subject to maximum of 10 % (ten percent only) of the value of the contract. The amount of Compensation may be adjusted or set-off against any sum payable to the Contractor under this or any other contract with the Corporation.
25. All the transit risk shall be responsibility of the tenderer.
26. Failure to complete the work in full within the stipulated period may lead to forfeiture of EMD and blacklisting of the tenderer.

27. The contractor will have to handover the premises in neat and clean condition and remove from site all debris and all other material and rubbish at his own cost before the work is taken over.
28. The electrical equipments/ fixtures should be of ISI marked as specified in tender.
29. The authorities are not bound to accept the lowest financial bid.
30. Terms and conditions of this tender document can not be negotiated for variations.
31. The department reserves the right to issue any corrigendum till ten days prior to the opening of the tender. The intending tenderers are advised to check the web site before submitting their offer.
32. The authority reserves the right to reject any or all tender in whole or part without assigning any reason and can impose any other condition(s) as deemed proper before or in course of finalisation of the tender.
33. The approved tender may be cancelled by the authority any time during validity without assigning any reason thereof and no claim can lie against OPHW&C for such cancellation.
34. Validity of tender shall be for 90 days from the date of opening of tender.
35. All the disputes shall be subject to Jurisdiction of Civil Courts situated at Bhubaneswar.

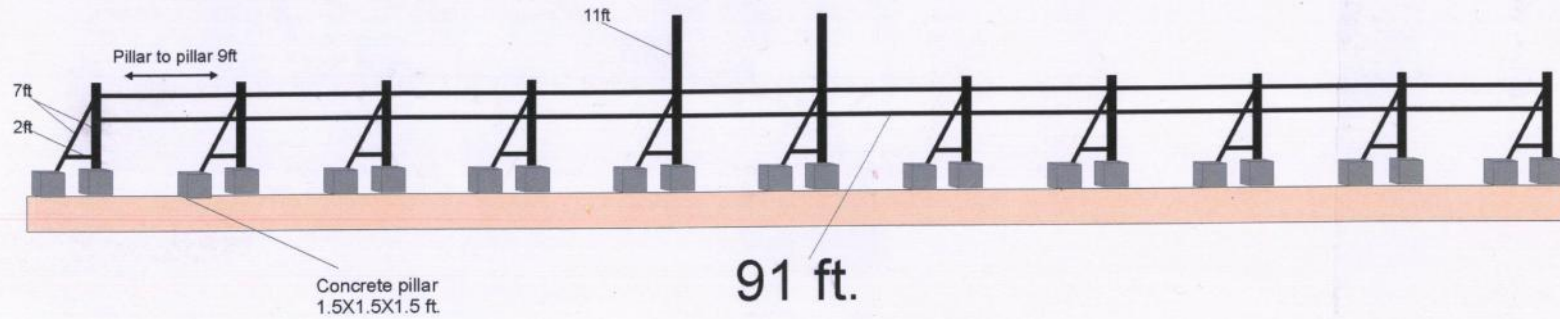

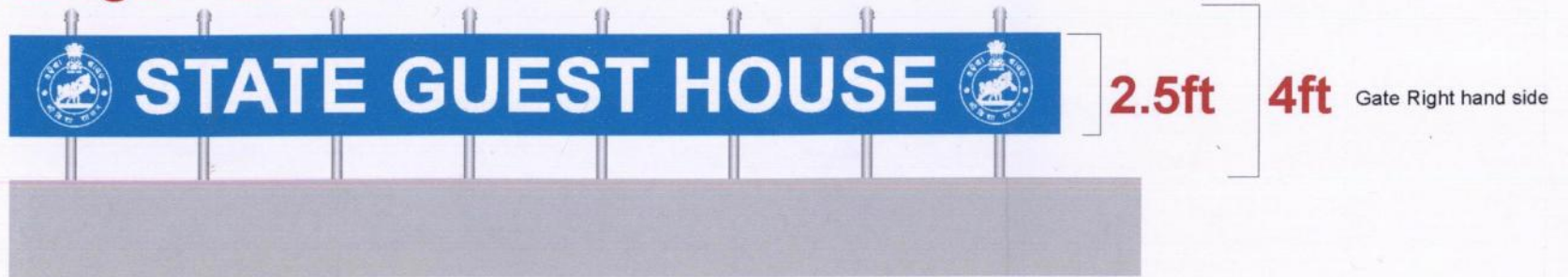
